## Chapter 44

An Act to Legalize the Acts, Doings, and Proceedings of the Town Meetings of the Town of Otisfield and the Assessment of Taxes Thereof, for the Years Nineteen Hundred Twenty-four, Nineteen Hundred Twenty-five and Nineteen Hundred Twenty-six.

*Be it enacted by the People of the State of Maine, as follows:*

Doings of certain town meetings of Otisfield, made legal. The acts, doings and proceedings of the town meeting of the town of Otisfield in the county of Cumberland and state of Maine held on the third day of March, nineteen hundred and twenty-four, the town meeting of said town held on the second day of March, nineteen hundred and twenty-five and the town meeting of said town held on the first day of March, nineteen hundred and twenty-six, are severally hereby ratified, made legal and valid; also the assessment and commitment of taxes in said town of Otisfield for the years nineteen hundred twenty-four, nineteen hundred twenty-five and nineteen hundred twenty-six and the acts and doings of the municipal officers of said town, for said years, relating to the assessment and commitment of said taxes are hereby ratified, made legal and valid.

## Chapter 45

An Act to Ratify and Make Valid Quitclaim Deed Given by Highway Commission for Property Located Near State Ferry in Woolwich.

*Be it enacted by the People of the State of Maine, as follows:*

**Sec. 1. Deed of state highway commission to Laura E. Farnham, made valid.** That the quitclaim deed given by the state highway commission for the state of Maine to Laura E. Farnham of Woolwich in the county of Sagadahoc quitclaiming any interest that the state of Maine may have in and to certain land described in said deed, said deed being dated April twenty-second, nineteen hundred twenty-six, is hereby ratified and made valid.

**Sec. 2. Deed of Laura E. Farnham to state of Maine, made valid.** That the quitclaim deed given by Laura E. Farnham of Woolwich in the county of Sagadahoc to the state of Maine quitclaiming any interest that the said Laura E. Farnham may have in and to certain land described in said deed, said deed being dated April twelfth, nineteen hundred twenty-six, is hereby made valid.
