Chapter 103

An Act Relating to the Oxford County Agricultural Society.

Be it enacted by the People of the State of Maine, as follows:

P. & S. L., 1841, c. 166, sec. 1; as amended; relating to corporators, corporate name, powers and privileges, further amended. Section one of chapter one hundred sixty-six of the private and special laws of eighteen hundred forty-one as amended by chapter one hundred fifty-two of the private and special laws of eighteen hundred eighty-seven, is hereby further amended by striking out in the thirteenth and fourteenth lines thereof the words "three hundred" and inserting in place thereof the words 'three thousand,' and by adding after the word "legislature" in the last line of said section one, the following words: 'Any resident of the state shall have the right to enter any contest or make any exhibit at said Oxford County Agricultural Society for the purpose of competing for and receiving premiums or prizes from the said society,' so that said section as amended shall read as follows:

'Sec. 1. Limitation on income increased; exhibits open to state. That John Kimball, Franklin Hosmer, Levi Brown, John Warner, Esrom Kimball, Noah Prince, Job Prince, Charles Andrews and G. W. Cushman, together with their associates and successors, be, and they are hereby constituted a body corporate and politic, by the name of the Oxford County Agricultural Society, with power to prosecute and defend suits at law, to have and use a common seal; to make and enforce any by-laws and regulations for the management of their affairs, not repugnant to the laws of the state; to take, hold, and use any estate, real or personal, the yearly income of which shall not exceed three thousand dollars, to be used and employed exclusively for the promotion and improvement of agricultural (agriculture), horticultural (horticulture), mechanic arts, and manufactures connected therewith; and said corporation shall have power to lease, sell, convey, or otherwise dispose of their funds as may best promote the object of their association: Provided, nevertheless, that the powers herein granted may be enlarged, restricted, or annulled, at the pleasure of the legislature. Any resident of the state shall have the right to enter any contest or make any exhibit at said Oxford County Agricultural Society for the purpose of competing for and receiving premiums or prizes from the said society.'
