## Chapter 7.

Resolve, in Favor of the Cornish Agricultural Association for Stipend for Nineteen Hundred and Twenty-two.

**Cornish Agricultural Association, payment of claim. Resolved:** That there be paid to the Cornish Agricultural Association for stipend due from the state in nineteen hundred and twenty-two, two hundred fifty-six dollars and forty-seven cents.

Approved February 11, 1927.

## Chapter 8.

Resolve, in Favor of the Town of Cornish to Reimburse It for the Support of Nanum Littlefield and Wife, State Paupers.

**Cornish, town of, payment of claim. Resolved:** That there be paid to the town of Cornish to reimburse it for the support of Nanum Littlefield and wife, state paupers, two hundred nine dollars and twenty cents.

Approved February 12, 1927.

## Chapter 9.

Resolve, in Favor of the Town of Berwick to Reimburse It for Support of George Perry, State Pauper.

**Berwick, town of, payment of claim. Resolved:** That there be paid to the town of Berwick to reimburse it for support of George Perry, a state pauper, four hundred thirty-five dollars and twenty-two cents.
