Chapter 43.

Resolve, in Favor of Animal Husbandry.

Animal husbandry, scientific investigation. Resolved: That there be, and hereby is, appropriated the sum of five thousand dollars for the year from July first, nineteen hundred and twenty-seven, to June thirtieth, nineteen hundred and twenty-eight, and five thousand dollars for the year from July first, nineteen hundred and twenty-eight, to June thirtieth, nineteen hundred and twenty-nine, for scientific investigation in animal husbandry. Said sum to be expended under the direction of the Maine agricultural experiment station.

Approved March 14, 1927.

Chapter 44.

Resolve, Making Appropriation for the Support and Maintenance of the Maine Agricultural Experiment Station.

Maine agricultural experiment station, appropriation. Resolved: That there be, and hereby is, appropriated the sum of twenty thousand dollars for the fiscal year commencing July first, nineteen hundred and twenty-seven, and twenty thousand dollars for the fiscal year beginning July first, nineteen hundred and twenty-eight, to be expended under the direction of the Maine agricultural experiment station for supplementing and making more effective the work now being carried on by said station under the federal grant known as the "Hatch Act." This annual appropriation is to be applied for general maintenance and for the purposes recommended in the report covering the needs of said station made by a special committee of the Maine federation of agricultural associations on April second, nineteen hundred and twenty-four, including providing quarters for the members of the station staff while on duty at the experimental farms during the summer.

Chapter 45.

Resolve, in Favor of Highmoor Farm, in the Town of Monmouth.

Highmoor farm, maintenance of. Resolved: That there be, and hereby is, appropriated the sum of five thousand dollars for the year from July first, nineteen hundred and twenty-seven, to June thirtieth, nineteen hundred and twenty-eight, and five thousand dollars for the year from July first, nineteen hundred and twenty-eight, to June thirtieth, nineteen hundred and twenty-nine, for the maintenance of Highmoor Farm, in the town

of Monmouth. Said sum to be expended under the direction of the Maine agricultural experiment station.

Approved March 14, 1927.

Chapter 46.

Resolve, in Favor of the Cobbosseecontee Fish and Game Association.

Cobbosseecontee Fish and Game Ass'n, screening lake. Resolved: That the sum of two hundred and fifty dollars be paid to the Cobbosseecontee Fish and Game Association of Augusta, Kennebec county, Maine, to reimburse said association for one-half the amount expended from its treasury on account of screening Cobbosseecontee Lake, said sum to be taken from the funds of the department of inland fisheries and game.

Chapter 47.

Resolve, for Teacher's Pension for Etta M. Patten.

Etta M. Patten, teacher's pension. Resolved: That there be paid to F.tta M. Patten of Corinna, a pension of two hundred dollars per year, payable quarterly, from the fund appropriated for teachers' pensions, beginning July first, nineteen hundred and twenty-seven, and continuing during the remainder of her life.

Approved March 15, 1927.

Chapter 48.

Resolve, to Reimburse the Town of Smyrna for Support of John Pomeroy, a Civil War Veteran.

Smyrna, town of, payment of claim. Resolved: That there be, and hereby is, appropriated to be paid to the town of Smyrna the sum of fifteen hundred and forty-five dollars, to reimburse said town for expenses of the support of John Pomeroy, a civil war veteran.

(This Resolve became effective without the approval of the Governor.)

Resolve, in Favor of Clifford T. Kennedy of Vanceboro, for Reimbursement for Expenditures for Civil Suit Brought Against Him.
