Chapter 93.

Resolve, in Favor of the Penobscot Tribe of Indians for the General Care, Maintenance, and Education Thereof.

Penobscot tribe of Indians, care and maintenance. Resolved: That there be, and hereby is, appropriated from the state treasury to be expended, under the direction of the governor and council, by the agent of the Penobscot tribe of Indians, for the benefit of said tribe, for the year from July first, nineteen hundred and twenty-seven, to June thirtieth, nineteen hundred and twenty-eight, and for the year from July first, nineteen hundred and twenty-eight, to June thirtieth, nineteen hundred and twenty-nine as follows:

And be it further resolved, that any balance of any of the sub-divisions above named and not required for the purpose, may, upon recommendation of the state auditor, be transferred by the governor and council to pay bills against any of the above sub-divisions, where bills may have been contracted in excess of the amount above set forth.

Chapter 94.

Resolve, in Favor of A. H. Wadleigh, Compensating Him for Damage Done His Orchard by Deer.

A. H. Wadleigh, payment of claim. Resolved: That there be, and hereby is, appropriated the sum of one thousand dollars to be paid A. H. Wadleigh of Limerick to reimburse him for damage done his orchard by deer during the years nineteen hundred twenty-five and nineteen hundred twenty-six, said orchard being situated in said Limerick.

(This Resolve became effective without the approval of the Governor.)
