## Chapter 124.

Resolve, to Reimburse the City of Bangor for Support of Richard Googins, a State Pauper.

**Bangor, city of, payment of claim. Resolved:** That there be, and hereby is, appropriated to be paid to the city of Bangor, the sum of eight hundred forty-four dollars and thirteen cents, to reimburse said city for money expended for support of Richard Googins, a state pauper.

## Chapter 125.

Resolve, to Reimburse the Town of Danforth for Support of Isaac Paul and Family, Indians.

**Danforth, town of, payment of claim. Resolved:** That there be, and hereby is, appropriated to be paid to the town of Danforth, the sum of thirty-four dollars, to reimburse said town for money expended for support of Isaac Paul and family, Indians.

## Chapter 126.

Resolve, Reimbursing the Town of Island Falls for Money Paid to the Family of Josiah H. Hunt, a Soldier of the World War.

**Island Falls, town of, payment of claim. Resolved:** That the sum of six hundred and fifteen dollars be, and hereby is, appropriated for the year nineteen hundred twenty-seven to be paid to the town of Island Falls to reimburse said town for payments made by said town to the dependents of Josiah H. Hunt, a soldier of the World War, by virtue of and under the public laws of nineteen hundred nineteen, chapter one hundred sixty-nine.

## Chapter 127.

Resolve, to Reimburse the City of Bangor for Support of Thomas Burns, a State Pauper.

**Bangor, city of, payment of claim. Resolved:** That there be, and hereby is, appropriated to be paid to the city of Bangor the sum of one hundred ninety-nine dollars and two cents, to reimburse said city for money expended for support of Thomas Burns, a state pauper.
