### Chapter 132.

Resolve, to Reimburse the City of Old Town for Support of Joseph Pelkey, a State Pauper.

**Old Town, city of, payment of claim. Resolved:** That there be, and hereby is, appropriated to be paid to the city of Old Town, the sum of fifty-five dollars, to reimburse said city for money expended for support of Joseph Pelkey, a state pauper.

### Chapter 133.

Resolve, to Reimburse the Town of Vanceboro for Support of Otis L. Crocker, a State Pauper.

**Vanceboro, town of, payment of claim. Resolved:** That there be, and hereby is, appropriated to be paid to the town of Vanceboro, the sum of seven hundred and thirty-one dollars and sixty-four cents, to reimburse said town for money expended for support of Otis L. Crocker, a state pauper.

### Chapter 134.

Resolve, to Reimburse the Town of Kingman for Support of Thomas Robichaud, a State Pauper.

**Kingman, town of, payment of claim. Resolved:** That there be, and hereby is, appropriated to be paid to the town of Kingman, the sum of two thousand five hundred and sixty-one dollars and fourteen cents, to reimburse said town for money expended for support of Thomas Robichaud, a state pauper.

### Chapter 135.

Resolve, to Reimburse Reed Plantation for Support of a State Pauper.

**Reed plantation, payment of claim. Resolved:** That there be, and hereby is, appropriated to be paid to Reed Plantation the sum of four hundred and twenty-five dollars and five cents, to reimburse said plantation for money expended for support of Hattie E. Black, otherwise known as Hattie E. Flinn, a state pauper.
