CHAP. 147

Chapter 147.

Resolve, in Favor of Frank Tozier for Reimbursement for Money Expended While Working as Constable in Smallpox Quarantine.

Frank Tozier, payment of claim. Resolved: That there be, and hereby is, appropriated to be paid to Frank Tozier, to reimburse him for services and money expended while working as constable in smallpox quarantine, the sum of fifty dollars balance due.

Approved April 11, 1927.

Chapter 148.

Resolve, to Reimburse the Town of Littleton for Care and Burial Expenses of Arthur Berube, or Burby, a Spanish War Veteran Having No Settlement in the State.

Littleton, town of, payment of claim: Resolved: That there be, and hereby is, appropriated to be paid to the town of Littleton the sum of two hundred and thirty-seven dollars and fifty cents, to reimburse said town for care and burial expenses of Arthur Berube, or Burby, a Spanish war veteran having no settlement in the state.

Approved April 11, 1927.

Chapter 149.

Resolve, in Favor of the County of Somerset, for Reimbursement for Expenses Incurred in the Sickness and Death of John Stewart.

Somerset, county of, payment of claim. Resolved: That there be, and hereby is, appropriated, to be paid the county of Somerset, for reimbursement of expenses incurred in the sickness and death of John Stewart, the sum of two hundred twenty dollars.

Approved April 11, 1927.

Chapter 150.

Resolve, to Reimburse the Town of Phippsburg for Burial Expenses of the Child of John Murphy, Jr., a Former Resident of Malaga Island.

Phippsburg, town of, payment of claim. Resolved: That there be, and hereby is, appropriated to be paid to the town of Phippsburg, the sum of twenty-six dollars, to reimburse said town for money expended for burial expenses of the child of John Murphy, Jr., a former resident of Malaga Island.

Approved April 11, 1927.
