Chapter 171.

Resolve, in Favor of the Trustees of the University of Maine.

Trustees University of Maine, expenses. Resolved: That there be, and hereby is, appropriated the sum of one thousand, five hundred dollars for the fiscal year commencing July first, nineteen hundred and twenty-seven, and one thousand, five hundred dollars for the fiscal year beginning July first, nineteen hundred and twenty-eight, for the purpose of paying traveling expenses of the trustees of the University of Maine incurred by them in the execution of their official duties.

Chapter 172.

Resolve, to Appropriate Money for the Purpose of Operating Fish Hatcheries and Feeding Stations for Fish, for the Protection of Fish, Game and Birds and for Printing the Report of the Commissioner of Inland Fisheries and Game, and for Maintenance of the Maine State Museum and for Other Expenses Incident to the Administration of the Department of Inland Fisheries and Game.

Department of Inland Fisheries and Game, appropriation. Resolved: That the sum of three hundred and seventy thousand dollars be, and hereby is, appropriated, as follows:

One hundred and eighty-five thousand dollars for the period between July first, nineteen hundred and twenty-seven, and June thirtieth, nineteen hundred and twenty-eight, and one hundred and eighty-five thousand dollars for the period between July first, nineteen hundred and twenty-eight, and June thirtieth, nineteen hundred and twenty-nine, to be expended by the commissioner of inland fisheries and game for the purpose of operating the fish hatcheries and feeding stations for fish in the state, for the protection of fish, game and birds, for printing the report of the commissioner of inland fisheries and game, for maintenance of the Maine state museum, payment of bounty on bob-cats killed in this state, and for the payment of damages done by deer, protected animals and birds, to growing crops and orchards, not exceeding five thousand dollars for each

of said years between June thirtieth, nineteen hundred and twenty-seven, and June thirtieth, nineteen hundred and twenty-nine; and payment of such damages previously done to growing crops and orchards as are allowed by the present Legislature, and all other expenses incident to the administration of the department of inland fisheries and game, and that any of this appropriation unexpended at the end of either year shall be available for the following year, as a continuing account.

Chapter 173.

Resolve, in Favor of the Maine School for the Deaf.

Maine school for the deaf, maintenance, etc. Resolved: That there be, and hereby is, appropriated for the Maine School for the Deaf for the fiscal year from July first, nineteen hundred and twenty-seven to June thirtieth, nineteen hundred and twenty-eight, the sum of sixty thousand five hundred dollars, of which there shall be applied for personal services, thirty thousand dollars, for maintenance, nineteen thousand dollars, for repairs and equipment, five thousand five hundred dollars and for installation of a sprinkler system and fire escapes and other improvements, six thousand dollars; and for the fiscal year July first, nineteen hundred and twenty-eight to June thirtieth, nineteen hundred and twenty-nine, sixty thousand five hundred dollars, of which there shall be applied for personal services, thirty thousand dollars, for maintenance, nineteen thousand dollars, for repairs and equipment, five thousand five hundred dollars and for installation of a sprinkler system and fire escapes and other improvements, six thousand dollars.

Chapter 174.

Resolve, in Favor of the Bath Military and Naval Orphan Asylum.

Bath military and naval orphan asylum, maintenance, etc. Resolved: That there be paid to the Bath Military and Naval Orphan Asylum for personal services eight thousand dollars (\$8,000) for the period from July first, nineteen hundred and twenty-seven to June thirtieth, nineteen hundred and twenty-eight, and eight thousand dollars (\$8,000) for the period from July first, nineteen hundred and twenty-eight to June thirtieth, nineteen hundred and twenty-nine.

That there be paid to the aforementioned institution, for maintenance fifteen
