### Chapter 173.

Resolve, in Favor of the Maine School for the Deaf.

**Maine school for the deaf, maintenance, etc. Resolved:** That there be, and hereby is, appropriated for the Maine School for the Deaf for the fiscal year from July first, nineteen hundred and twenty-seven to June thirtieth, nineteen hundred and twenty-eight, the sum of sixty thousand five hundred dollars, of which there shall be applied for personal services, thirty thousand dollars, for maintenance, nineteen thousand dollars, for repairs and equipment, five thousand five hundred dollars and for installation of a sprinkler system and fire escapes and other improvements, six thousand dollars; and for the fiscal year July first, nineteen hundred and twenty-eight to June thirtieth, nineteen hundred and twenty-nine, sixty thousand five hundred dollars, of which there shall be applied for personal services, thirty thousand dollars, for maintenance, nineteen thousand dollars, for repairs and equipment, five thousand five hundred dollars and for installation of a sprinkler system and fire escapes and other improvements, six thousand dollars.

### Chapter 174.

Resolve, in Favor of the Bath Military and Naval Orphan Asylum.

**Bath military and naval orphan asylum, maintenance, etc. Resolved:** That there be paid to the Bath Military and Naval Orphan Asylum for personal services eight thousand dollars (\$8,000) for the period from July first, nineteen hundred and twenty-seven to June thirtieth, nineteen hundred and twenty-eight, and eight thousand dollars (\$8,000) for the period from July first, nineteen hundred and twenty-eight to June thirtieth, nineteen hundred and twenty-nine.

That there be paid to the aforementioned institution, for maintenance fifteen
