As Passed by the Eighty-Third
Legislature

1927

Completion of revision; report to be printed. Resolved that said commissioner shall complete said revision in separate titles, chapters and sections and on or before the first day of the regular session of the next legislature shall cause five hundred copies thereof, with the constitution of the United States and of this state and his report, to be printed and bound in paper or board covers by such person as shall be employed in accordance with the following resolution for the use of the state and said commissioner shall superintend said printing.

Governor and council to arrange details; compensation and expenses of commissioner. Resolved that the governor and council be, and hereby are, authorized to arrange the details for the services, and compensation of said commissioner and to provide for the printing and binding thereof by the state printer and binder. Provided, that the compensation of said commissioner, his expenses and clerical assistance and stationery for said revision and report, shall not exceed the sum of fifteen thousand dollars. In the event of a vacancy occurring in the office of the commissioner by death, resignation or incapacity to fill the office, the governor with the advise and consent of the council, shall fill said vacancy.

Contract may be made with publishers of legal works. Resolved that the governor and council are hereby authorized and empowered, if they deem it expedient in lieu of appointing a commissioner as hereinabove provided, to make a contract for said report and said revision in the name of the state of Maine with one or more publishers of legal reports or legal text books. In the event that such a contract be made instead of the appointment of a commissioner, the contract shall include as near as may be, the provisions of this act applicable to a commissioner.

Appropriation. Resolved that for the foregoing purposes, there be, and hereby is, appropriated out of any moneys in the treasury not otherwise appropriated, the sum of fifteen thousand dollars or so much thereof as may be necessary, to be paid on warrants drawn by the governor with the advice and consent of the council, in such amounts and at such times as the governor and council may approve. Said appropriation to be available at any and all times between the time of this act shall be effective and June thirtieth, nineteen hundred and twenty-nine.

Chapter 180.

Resolve, in Favor of Opportunity Farm for Assistance in Obtaining a Supply of Pure Water.

Opportunity farm, appropriation for drilling well. Resolved: That

there be and hereby is appropriated to be paid to Opportunity Farm at New Gloucester, for the drilling of an artesian well with which to supply its buildings, the sum of twenty-five hundred dollars, the same to be paid to said institution upon its filing proper vouchers with the state auditor.

Chapter 181.

Resolve, in Favor of Procuring Testimonials for the Purpose of Marking the Unmarked Graves of the Soldiers of the Revolutionary War.

Revolutionary soldiers grave markers, appropriation for. Resolved: That the sum of six hundred dollars be and hereby is appropriated for the purpose of procuring testimonials to be used in marking the unmarked graves of the soldiers of the Revolutionary War.

Resolved further: That said sum be paid into the treasury of the Sons of the American Revolution, with which they are hereby authorized to procure and distribute such number of markers as may, from time to time, be required for the purposes herein specified.

Chapter 182.

Resolve, in Favor of Frank R. Chesley, B. W. Blanchard and Gillen & Gillen.

Attorneys in highway investigation, payment of. Resolved: That there be, and hereby is, appropriated to be paid to Frank R. Chesley, the sum of eleven hundred sixty-five dollars for services rendered as attorney in the highway investigation, held before a joint committee, of the eighty-third legislature of Maine.

That there be, and hereby is, appropriated to be paid to B. W. Blanchard, the sum of eleven hundred sixty-five dollars for services rendered as attorney in the highway investigation, held before a joint committee, of the eighty-third legislature of Maine.

That there be, and hereby is, appropriated to be paid to Gillen & Gillen, the sum of six hundred thirty-eight dollars and eighty-five cents, for services rendered as attorneys in the highway investigation, held before a joint committee of the eighty-third legislature of Maine.

Said amounts to be paid out of funds appropriated for the use of the eighty-third legislature.
