## Chapter 224.

Resolve, in Favor of Murtagh Hughes of Bangor to Reimburse Him, for Loss Sustained in Construction of State Highway at Edgecomb.

**Murtagh Hughes, payment of claim. Resolved:** That there be, and hereby is, appropriated the sum of eight thousand dollars, said sum to be paid out of the state highway bond money, to reimburse Murtagh Hughes of Bangor, Maine, for loss sustained by him in the construction of state highway at Edgecomb.

Approved April 16, 1927.

## Chapter 225.

Resolve, Appropriating Money for the Purchase of Additional Real Estate for the State School for Girls.

**State school for girls, to purchase land. Resolved:** That there be and hereby is appropriated the sum of eight hundred dollars for the purchase of additional real estate situate in Hallowell, Kennebec county, Maine, needed by the state school for girls, for pasturage.

The same to be expended and said purchase made by the trustees of said institution subject to the approval of the governor and council.

## Chapter 226.

Resolve, in Favor of State School for Girls.

**State school for girls, maintenance, etc. Resolved:** That there be, and hereby is, appropriated for the state school for girls for the fiscal year, July first, nineteen hundred twenty-seven, to June thirtieth, nineteen hundred twenty-eight, inclusive, the sum of eighty thousand, five hundred forty dollars and ninety-six cents for the purposes hereinafter specified, namely:

Personal services for salaries and wages of officers and employees,	\$25,000.00
Maintenance for food supplies, wearing apparel, all articles of personal clothing and materials for their fabrication and repair,	42,000.00
Repairs and equipment, all materials, supplies and labor required for repairs and upkeep of grounds, buildings, and attached fixtures,	13,000.00

**CHAP. 227**

Interest on trust funds, 540.96

And be it further resolved, that there be and hereby is appropriated for the state school for girls for the fiscal year July first, nineteen hundred twenty-eight to June thirtieth, nineteen hundred twenty-nine, inclusive, the further sum of eighty thousand, five hundred forty dollars and ninety-six cents for the purposes hereinafter specified, namely:

Personal services for salaries and wages of officers and employees, \$25,000.00

Maintenance for food supplies, wearing apparel, all articles of personal clothing and materials for their fabrication and repair, 42,000.00

Repairs and equipment, all materials, supplies and labor required for repairs and upkeep of grounds, buildings, and attached fixtures, 13,000.00

Interest on trust funds, 540.96

Provided, that the governor and council, may, by order, upon recommendation of the trustees of said institution, authorize the use of unexpended balances of any of the above appropriations to meet deficiencies in other appropriations for the same institution.

### Chapter 227.

Resolve, to Compensate Augustus A. Gilbert, a Farmer of Brewer, for a Cow Shot by a Hunter.

Augustus A. Gilbert, payment of claim. Resolved: That the state of Maine pay to Augustus A. Gilbert, a farmer of Brewer, the sum of fifty dollars to compensate him for a cow shot by a hunter on the first day of the hunting season of the year nineteen hundred twenty-six.

Approved April 16, 1927.

### Chapter 228.

Resolve, in Favor of Upper Eridge in the Town of Frankfort, Waldo County.

Frankfort, town of, for construction of bridge. Resolved: That there be, and hereby is, appropriated the sum of two thousand dollars to aid the town of Frankfort in the reconstruction of Upper Bridge, located in Frankfort village, on State Highway "L," Route 1.
