Chapter 248.

Resolve, in Favor of Charitable, and Benevolent Institutions, for the Care, Support
and Medical or Surgical Treatment of Certain Persons.

Charitable and benevolent institutions, in aid of. Resolved: That there be, and hereby is, appropriated for the fiscal year from July first, nineteen hundred and twenty-seven to June thirtieth, nineteen hundred and twenty-eight, the sum of two hundred twelve thousand nine hundred dollars and for the fiscal year from July first, nineteen hundred and twenty-eight to June thirtieth, nineteen hundred and twenty-nine, the sum of two hundred ten thousand nine hundred dollars, for the necessary care and medical or surgical treatment, at the rates specified and in, or by, the institutions and organizations named, of certain classes of persons whose own resources or the resources of whose responsible relatives as defined by section eighteen of chapter twenty-nine of the revised statutes, are insufficient to pay for the same, and for other purposes, namely:

For the care and support of children under sixteen years of age including those supported away from their parents under the provisions of sections fifty-one to fifty-five inclusive, chapter sixty-four of the revised statutes, and acts amendatory thereof, at not to exceed three dollars and fifty cents per week, including direct payments from sources other than the state:
