certified to by the clerk, treasurer, or any of the municipal officers of the town wherein the applicant resides, or wherein the ceremony is to be performed. Upon receipt of such application the secretary of state shall issue to the applicant a license under the seal of the state to the effect that he is authorized to solemnize marriages in this state. Such license, or a certified copy thereof shall be received as evidence in all courts of his authority in the premises, and a copy of the record of any marriage solemnized by such licensee duly made and kept, attested or sworn to by the clerk of the town in which the marriage intention was recorded or in which the marriage was solemnized shall be received in all courts as evidence of the fact of marriage. Such license shall continue until revoked by the governor for cause, after notice and an opportunity to be heard thereon.'

## Chapter 83.

An Act to Repeal Sections Four to Ten Inclusive of Chapter Thirty-nine of the Revised Statutes Relative to Public Warehouses and Warehousemen.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 39, sections 4 to 10 inclusive; relating to public warehouses and warehousemen, repealed. Sections four to ten inclusive of chapter thirtynine of the revised statutes are hereby repealed.

### Chapter 84.

An Act to Correct a Clerical Error in Section One of Chapter Two Hundred and Twenty-two of the Public Laws of Nineteen Hundred and Twenty-three.

Be it enacted by the People of the State of Maine, as follows:

P. L. 1923, c. 222, sec. 1; relating to investment of permanent funds of towns and cities, amended. Section one of chapter two hundred and twenty-two of the public laws of nineteen hundred and twenty-three is hereby amended by striking out the word "two" in the fourteenth line of said section and adding in place thereof the word 'four,' so that said section, as amended, shall read as follows:

'Sec. I. So much of section 72 of chapter four, revised statutes, inconsistent with this act, repealed. City and town officers of quasi-municipal corporations shall hereafter invest all permanent funds, including sinking funds, permanent school funds and money or credits deposited with them for perpetual care of lots in cemeteries, in the legal obligations of the United States of America; the states of Maine, New Hampshire, Vermont,

### QUARANTINE OF CATTLE.

#### CHAP. 85

Massachusetts, Rhode Island, Connecticut, New York and Pennsylvania, and the bonds of the several counties, cities and towns in the several states above named, which are the direct obligation of said counties, cities and towns, or may deposit the same on time deposit in banks or trust companies, organized under the laws of this state, and not otherwise, and unless otherwise specifically provided by the terms of the grant or bequest the annual income, only, shall be expended in performance of the requirements of the trust. So much of section seventy-two of chapter four, revised statutes, section fifty-four, of chapter seventeen, revised statutes, and section fourteen, chapter twenty-one, revised statutes, as are inconsistent with this act are hereby repealed.'

## Chapter 85.

#### An Act Relating to the Quarantine of Cattle.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 35; P. L., 1925, c. 24; relating to the prevention of contagious diseases among animals, further amended. Chapter thirty-five of the revised statutes as amended by chapter twenty-four of the public laws of nineteen hundred and twenty-five, is hereby further amended by striking out in the twenty-fourth section thereof, the words "such quarantine to remain until all animals within the area designated shall be subject to the tuberculin test or other test or examination satisfactory to the commissioner of agriculture or his agent"; so that said section as amended shall read as follows:

'Sec. 24. Commissioner of agriculture empowered to prohibit moving of cattle to and from diseased area; may quarantine. The commissioner of agriculture or his agent in charge of live stock sanitary work is hereby empowered to prohibit the movement of cattle of every description into or from any area where bovine tuberculosis or other contagious disease is known to exist and where the commissioner of agriculture or his agent has assumed charge of such disease eradication. If any animals are brought into any such area in violation of this regulation the commissioner of agriculture or his agent shall be further empowered to quarantine such animals until they shall be tested by an accredited veterinarian at the expense of the owner.'
