## Chapter 148.

An Act to Prohibit Lobster Fishing in Certain Waters of Winter Harbor and Gouldsboro.

*Be it enacted by the People of the State of Maine, as follows:*

**July and August close time in waters of Winter Harbor and Gouldsboro.** It shall be unlawful to set any trap or other device used for the catching of lobsters, or to take and catch any lobsters within the following described limits, during the months of July and August of each year: from Jordan's island in the town of Gouldsboro to Egg rock, thence easterly in a straight line to the southern end of Turtle island, thence easterly in a straight line to the southern end of Mark island, thence in a due east course to the Schoodic shore in the town of Winter Harbor.

## Chapter 149.

An Act Regarding Disposition of Motor Vehicle Fees.

*Be it enacted by the People of the State of Maine, as follows:*

P. L., 1921, c. 211, sec. 92; P. L., 1927, c. 122; relating to moneys collected to be used for repair and maintenance of state highways, further amended. Section ninety-two of chapter two hundred and eleven of the public laws of nineteen hundred and twenty-one, as amended by chapter one hundred and twenty-two of the public laws of nineteen hundred and twenty-seven, is hereby further amended by inserting the words, 'an amount equivalent thereto' after the word "and" in the third line thereof, so that said section as amended shall read as follows:

'Sec. 92. Amount equivalent to moneys received shall be appropriated and used. All fees and moneys received by the secretary under the preceding sections shall be turned over to the treasurer of state as provided in section twenty-six of this act and an amount equivalent thereto shall be appropriated and used for the administration of the office and duties of the commission as provided by general law, including the expenses of administering the motor vehicle department and the licensing of operators and registration of vehicles, and for the repair and maintenance of state and state aid highways under the direction of the commission and to meet all provisions of the bond issues for highways construction as heretofore provided by statute.'
