attorney general. The attorney general shall at the request of any state department, make or cause to be made investigations in behalf of such department and he shall also prosecute any case to such extent as may seem advisable with all the rights, powers and privileges of county attorneys; and the expense of any such investigation and of any prosecution which results from such investigation shall be charged to this appropriation.'

## Chapter 186.

An Act to Protect Muskrats in the Town of Orrington, in the County of Penobscot.  
*Be it enacted by the People of the State of Maine, as follows:*

**Sec. 1. Close time on muskrats.** It shall be unlawful for any person to hunt, trap, kill, pursue or catch any muskrat, or muskrats, at any time in the stream running from Swetts pond to Penobscot river in the town of Orrington in the county of Penobscot.

**Sec. 2. Unlawful possession.** It shall also be unlawful for any person to have in possession, at any time, any muskrat, or muskrats, or part thereof, taken in violation of any provision of this act.

**Sec. 3. Penalty for violation.** Whoever violates any provision of this act shall be subject to a penalty of not less than ten dollars and costs for each offense, and three dollars additional for each muskrat or part thereof hunted, killed, trapped, pursued, caught, or had in possession, in violation hereof.

## Chapter 187.

An Act Relating to Fees of Sheriffs and Their Deputies.

*Be it enacted by the People of the State of Maine, as follows:*

**R. S., c. 118, sec. 5; as amended; relating to sheriffs and their duties, further amended.** Paragraph twenty-three of section five of chapter one hundred and eighteen of the revised statutes, as amended, is hereby further amended by striking out in the second line thereof the word "four" and inserting the word 'five,' so that said paragraph, as amended, will read as follows:

**Increase to \$5.00 a day for special duties.** 'Every deputy sheriff, while performing special duties under order of the sheriff shall receive for such services five dollars a day; together with necessary, incidental expenses, to be paid from the county treasury, the bills for which shall be audited
