Chapter 342.

An Act to Regulate Fishing in Clearwater Pond.

Be it enacted by the People of the State of Maine, as follows:

Fishing in Clearwater pond regulated. It shall be unlawful to fish for, take, catch or kill any kind of fish at any time in Clearwater pond situated in the towns of Industry and Farmington in the county of Franklin, except by trolling or by fly-fishing in the ordinary manner; provided, however, that plug fishing, so-called, from permanent wharf or shore with line not exceeding twenty feet in length shall be legal from June first of each year until September thirtieth following of each year, both days inclusive.

Approved April 13, 1929.

Chapter 343.

An Act Relating to Fishing in the Tributaries to St. Croix Lake in Aroostook County.

Be it enacted by the People of the State of Maine, as follows:

P. L., 1925, c. 27; relating to fishing in tributaries to St. Croix lake, repealed. Chapter twenty-seven of the public laws of nineteen hundred and twenty-five is hereby repealed.

Chapter 344.

An Act to Close the Tributaries to Big and Little Bear Pond, Situated in the Town of Hartford, Oxford County, and in the Town of Turner, Androscoggin County.

Be it enacted by the People of the State of Maine, as follows:

Close time on tributaries to Big and Little Bear pond. It shall be unlawful for any person to fish for, take, catch, kill or have in possession at any time any kind of fish in any of the tributaries to Big and Little Bear pond, which waters are situated partly in the town of Hartford, Oxford county, and partly in Turner, Androscoggin county.

Chapter 345.

An Act Relating to Fishing in Great Works Stream.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. Pickerel fishing in Great Works stream permitted. It shall be lawful to fish for, take, catch or kill pickerel at any time in Great Works

stream from the Penobscot river to Big Rock, so-called, in the town of Bradley.

Sec. 2. Inconsistent acts repealed. All acts and parts of acts inconsistent herewith are hereby repealed.

Approved April 13, 1929.

Chapter 346.

An Act Closing Songo Pond in the Towns of Albany and Bethel, in Oxford County,
to Ice Fishing.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. Ice fishing in Songo pond prohibited. It shall be unlawful for any person to fish for, take, catch or kill any kind of fish at any time, on or through the ice in Songo pond, which pond is situated in the towns of Albany and Bethel, in the county of Oxford.

Sec. 2. Penalty for violations. Whoever violates any provision of this act shall be subject to a fine of not less than ten dollars and not more than twenty dollars.

Chapter 347.

An Act Relating to Ice Fishing in Alewive Pond.

Be it enacted by the People of the State of Maine, as follows:

P. L., 1925, c. 82, sec. 1; relating to ice fishing in Alewive pond, amended. Section one of chapter eighty-two of the public laws of nineteen hundred and twenty-five is hereby amended by striking out the whole of said section and inserting in place thereof the following:

'Sec. 1. Unlawful to fish on any day except Monday; unlawful possession. It shall be unlawful for any person to fish for, take, catch or kill on any day other than Monday of each week, on or through the ice in Alewive pond in the town of Kennebunk, in the county of York.

It shall also be unlawful for any person to have in possession at any time, any kind of fish taken on or through the ice in said Alewive pond, except such as were caught on such Mondays.'
