CHAP. 96

free and clear of all indebtedness, the board of trustees shall automatically cease to function and all of the duties, management, care and maintenance in respect to such school building shall revert to the school board of the town of Rumford or such other board as may, at that time, have jurisdiction over similar school property, and the then president and treasurer shall cause to be executed, signed and delivered, a good and sufficient deed of all the property in said district, to the town of Rumford. All money, if any, remaining in the treasury of the board of trustees at the time it ceases to function, shall be given to the town treasurer of Rumford. This money shall be used only for school purposes and shall be kept separate from all other money until authorized by the selectmen of the town of Rumford to be expended as hereinbefore stated.

Sec. 7. Act subject to referendum. This act shall not take effect unless accepted and approved by a majority vote of the legal voters of the territory embraced within the limits of said district present and voting at an election to be specially called by the selectmen of the town of Rumford and held for that purpose within sixty days after the approval of this act. Such special election shall be called, advertised and conducted according to the law relating to municipal elections, provided, however, that the selectmen of the town of Rumford shall not be required to prepare for posting, or the town clerk to post a new list of voters, and for the purpose of registration of voters, said selectmen of the town of Rumford shall be in session the three secular days next preceding such elections. The town clerk shall reduce the subject matter of this act to the following question: "Shall the Act to Incorporate the Town of Rumford School District be Accepted?" and the voters shall indicate by a cross placed over the words "Yes" or "No" their opinion of the same. The result in said district shall be declared by the municipal officers of the town of Rumford and due certificate filed by the town clerk with the secretary of state.

Chapter 96.

An Act to Amend and Extend the Charter of Kennebec Reservoir Company. Be it enacted by the People of the State of Maine, as follows:

Sec. 1. P. & S. L., 1927, c. 113, sec. 1; relating to act to create Kennebec Reservoir Company, amended. Section one of chapter one hundred and thirteen of the private and special acts of nineteen hundred and twenty-seven is hereby amended by striking out the name of "Garrett Schenck" in the second line and inserting in the place thereof the name 'W. A. Whitcomb.'

Sec. 2. P. & S. L., 1927, c. 113, sec. 7; relating to drive to be made annually and regulation relating to drive, amended; leaving of trees, bushes and stumps regulated. Section seven of said act is hereby amended by striking out the first sentence of the second paragraph of said section seven, which reads as follows: "This corporation shall remove all growth on the area flowed by it seasonably to prevent it from falling and being carried away by the water, and in any event within four years of the commencement of said flowage" and inserting in the place of said sentence so stricken out the following: 'This corporation shall, within four years from the commencement of flowage, cut and remove all trees, bushes and stumps on the area flowed or to be flowed to such an extent that all such trees, bushes and stumps left on the flowed area shall at all times be at least eight feet below the surface of the water, but in no case shall it be required to remove stumps below the swell of the roots.'

Sec. 3. Charter extended. The rights, powers and privileges of the Kennebec Reservoir Company, which were granted by chapter one hundred and thirteen of the private and special laws of nineteen hundred and twenty-seven and as amended by this act, are hereby extended for the period of two years from the date when this act takes effect; and the persons named in said act as hereby amended, their associates, successors and assigns shall have all the rights, powers and privileges that were granted them, or their predecessors, by said act and the amendments thereto contained herein to be exercised in the same manner and for the same purposes as specified in said act as hereby amended.

Chapter 97.

An Act to Provide Better Government for the Town of Mount Desert. Be it enacted by the People of the State of Maine, as follows:

Sec. 1. Annual town meeting first Monday in March. Annual town meetings shall be held in the town of Mount Desert, in the county of Hancock, on the first Monday of March, in each year, and the voters shall then choose, by ballot, as now provided by law, a moderator and clerk.

Sec. 2. Officers. At such meetings as provided in section one, the voters shall then choose, by ballot, as provided by chapter one hundred and ninety-one, of the private and special laws for the year one thousand nine hundred and seventeen, three, five or seven inhabitants of said town to be selectmen and overseers of the poor, a treasurer and collector of
