CHAP. 104

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. Municipal officers authorized to establish territorial limits; land to be included. The municipal officers of South Paris Village Corporation are hereby authorized to establish the territorial limits of said corporation, and are authorized to include land embraced within the following limits: commencing at the center of Alpine street at the northeasterly corner of a piece of land set off to the town of Norway in eighteen hundred and fifty-nine; thence easterly on the southerly line of lot nine, range one to the southeasterly corner; thence northerly on the range line to the northwesterly corner of lot nine, range two; thence easterly on said lot line to the southeasterly corner of the Emery Record lot; thence northerly on the easterly line of the Record lot and a continuation of the same to the southerly line of the Otis Swift lot, now owned by Walter Gray; thence easterly on said Gray's south line to the Gray Meadow, so-called; thence southerly by said Gray Meadow to the Little Androscoggin river; thence southerly by said river to the north line of lot nine, range three; thence easterly by the north line of said lot to the northeast corner; thence southerly by said range line to the Burnell brook and the northeast corner of the J. Bickford lot, so-called; thence westerly and southerly by said Bickford lot to the East Oxford road; thence northerly and westerly by the west line of the old William Rice lot to the northerly line of lot six; thence westerly on the said lot line to the Little Androscoggin river; thence down said river to the Norway town line; thence northerly on said town line to the point of beginning, together with the inhabitants thereon.

Sec. 2. Not operative until ratified by voters. This act shall not be operative until it is ratified by a majority vote of the legal voters of South Paris Village Corporation at an annual or special meeting of said corporation called by a warrant containing an article for the purpose.

Chapter 104.

An Act Relating to the Salary of the Municipal Court Recorder of Sanford.

Be it enacted by the People of the State of Maine, as follows:

P. & S. L., 1915, c. 39, sec. 2; as amended; relating to salary of recorder of Sanford municipal court, further amended. Section two of chapter thirty-nine of the private and special laws of nineteen hundred and fifteen, as amended, is hereby further amended by striking out in the third line thereof the word "four" and inserting in place thereof the word 'eight,' so that said section, as amended, shall read as follows:

'Sec. 2. Salary increased. The recorder of the Sanford municipal court shall receive as compensation, an annual salary of eight hundred dollars, payable quarterly, on the first days of January, April, July and October, from the county treasury of the county of York. All fees received by him shall be paid over to the county treasurer.'

Chapter 105.

An Act Relating to Penobscot Council Incorporated, Boy Scouts of America, Bangor and Brewer, Maine.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. Corporate name changed. The corporate name of "Penobscot Council Incorporated, Boy Scouts of America, Bangor and Brewer, Maine," is hereby changed to 'Katahdin Council Incorporated, Boy Scouts of America.' The said corporation is authorized to use its original name of "Penobscot Council Incorporated, Boy Scouts of America, Bangor and Brewer, Maine," whenever for corporate convenience, in the opinion of its proper officers, it may be necessary or desirable so to do.

Sec. 2. Legal and valid as a benevolent and charitable institution. The corporate organization of said Boy Scout council is hereby declared to be legal and valid as a benevolent and charitable institution incorporated by the state of Maine within the meaning of chapter ten, section six, paragraph three, revised statutes of Maine, A. D. nineteen hundred and sixteen and acts amendatory thereto.

Chapter 106.

An Act Relating to the Western Washington Municipal Court.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. P. & S. L., 1921, c. 113; relating to establishing of the Western Washington municipal court, amended. Chapter one hundred and thirteen of the private and special laws of nineteen hundred and twenty-one is hereby amended by striking out the whole of section two thereof and inserting in place thereof the following section, so that said section, as amended, shall read as follows:

'**Sec. 2. Jurisdiction.** Said court shall exercise jurisdiction over all matters and things, civil and criminal, within its jurisdiction as herein-
