## Chapter 2.

Resolve, for Teacher's Pension for Etta M. Patten.

**Etta M. Patten, teacher's pension. Resolved:** That there be paid to Etta M. Patten of Corinna, a pension of two hundred fifty dollars per year, payable quarterly, from the fund appropriated for teachers' pensions, beginning July first, nineteen hundred and twenty-nine, and continuing during the remainder of her life.

Approved February 19, 1929.

## Chapter 3.

Resolve, in Favor of Isabelle Willett.

**Isabelle Willett, state pension. Resolved:** That there be paid to Isabelle Willett of Lewiston in the county of Androscoggin and state of Maine, the sum of twelve dollars per month, payable quarterly from the fund appropriated for soldiers' pension beginning January first, nineteen hundred and twenty-nine, and continuing during the pleasure of the legislature.

Approved February 19, 1929.

## Chapter 4.

Resolve, to Provide for a Pension for John W. Fish of Union.

**John W. Fish, state pension. Resolved:** That a pension of twelve dollars per month be, and hereby is granted to John W. Fish of Union to be paid quarterly from the fund for soldiers and their dependents. Said pension shall begin July first, nineteen hundred and twenty-nine, and continue until otherwise provided by the legislature.

Approved February 19, 1929.

## Chapter 5.

Resolve, Providing for a State Pension for Harrison M. Crocker of Whitefield.

**Harrison M. Crocker, state pension. Resolved:** That a pension of twenty dollars per month be, and hereby is, granted to Harrison M. Crocker, of Whitefield, to be paid quarterly from the fund for pensions for soldiers and their dependents. Said pension shall begin July first, nineteen hundred and twenty-nine and continue until otherwise provided by the legislature.

Approved February 22, 1929.
