RESOLVES

OF THE

STATE OF MAINE

As Passed by the Eighty-Fourth  
Legislature

Whereas, money for such building cannot be used until the funds provided by this resolve become available and loss and inconvenience will result if such work is not started early in the season, and

Whereas, the buildings of the Central Maine Sanatorium are not now adequately supplied with water for protection in case of fire, and

Whereas, in the judgment of the legislature these facts create an emergency within the meaning of section sixteen of article thirty-one of the constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health, and safety, now, therefore, be it

**Central Maine Sanatorium, for water main. Resolved:** That there be and hereby is appropriated for the Central Maine Sanatorium the sum of four thousand five hundred dollars for the laying of a six inch water main from the county highway to the sanatorium buildings, said sum to be available during the fiscal year from July first, nineteen hundred and twenty-nine to June thirtieth, nineteen hundred and thirty.

**Emergency clause.** In view of the emergency cited in the preamble this resolve shall take effect when approved.

## Chapter 14.

Resolve, in Favor of Silas L. Barrows of Waterville, to Compensate Him for Personal Injuries and Property Damage, Occasioned by His Being Shot by Hollis Spear, a State Ward.

**Silas L. Barrows, compensation for injuries and property damage. Resolved:** That there be, and hereby is, appropriated, to be paid to Silas L. Barrows of Waterville to compensate him for personal injuries and property damage, occasioned by his being shot by Hollis Spear, a state ward, the sum of two hundred and thirty-two dollars and sixty-five cents.

Approved March 1, 1929.

## Chapter 15.

Resolve, Providing for a State Pension for Eliza F. Withee of Vassalboro.

**Eliza F. Withee, state pension. Resolved:** That a pension of fifteen dollars per month be, and hereby is, granted to Eliza F. Withee, of Vassalboro, to be paid quarterly from the fund for pensions for soldiers and their dependents. Said pension shall begin July first, nineteen hundred and twenty-nine, and continue for two years.
