## CHAP. 25

state which shall by action of its legislature assent to the provisions of this act;" therefore, be it

**"Capper Ketchum Act"; assent given to by legislature. Resolved:** That the assent of the legislature of the state of Maine be and is hereby given to the provisions and requirements of said act, and that the trustees of the University of Maine be and they are hereby authorized and empowered to receive the grants of money appropriated under said act, and to organize and conduct agricultural extension work which shall be carried on in connection with the college of agriculture of said university, in accordance with the terms and conditions expressed in the act of congress aforesaid.

### Chapter 23.

Resolve, Authorizing the Forest Commissioner to Convey to the Gould Electric Company the Right to Flow a Certain Piece of Land on the Public Lot in Township Ten, Range Four, West of the East Line of the State, Aroostook County.

**Gould Electric Company, flowage rights. Resolved:** That the forest commissioner be and hereby is authorized to convey to the Gould Electric Company the right to flow about nine acres of land from the public lot in the northeast one-quarter of township ten, range four, west of the east line of the state, Aroostook county.

### Chapter 24.

Resolve, in Favor of Fred A. Budge, of Mattawamkeag.

**Fred A. Budge, payment of claim. Resolved:** That there be, and hereby is, appropriated, to be paid to Fred A. Budge of Mattawamkeag, in payment of gravel used on the state highway, the sum of four hundred sixty-seven dollars and fifty-five cents.

### Chapter 25.

Resolve, in Favor of the Bangor State Hospital.

**Bangor State Hospital, maintenance, etc. Resolved:** That there be, and hereby is, appropriated for the Bangor State Hospital:

For personal services; namely, for salaries and wages of all officers and employees except those wholly engaged in repairs of buildings and equipment for the year July first, nineteen hundred and twenty-nine to June thirtieth, nineteen hundred and thirty, the sum of one hundred twenty-seven thousand seven hundred dollars, and for the year July first, nineteen hundred and thirty to June thirtieth, nineteen hundred and thirty-one, the sum of one hundred twenty-seven thousand seven hundred dollars,

### Chapter 26.

Resolve, Providing for an Honorarium for Otis O. Roberts of Dexter.

**Otis O. Roberts, honorarium. Resolved:** That an honorarium of twenty-five dollars per month be, and hereby is, granted to Otis O. Roberts of Dexter, one of two surviving holders in Maine of the congressional medal of honor, for services rendered in the civil war. Said honorarium to be paid monthly from the fund for pensions for soldiers and sailors and their dependents. Said honorarium shall begin July first, nineteen hundred and twenty-nine, and shall continue until otherwise provided by the legislature, and shall be in lieu of the state pension which he is now receiving.

### Chapter 27.

Resolve, Authorizing the Forest Commissioner as Land Agent to Convey a Certain Lot of Land to W. Asahel Darling.

**W. Asahel Darling, conveyance of land. Resolved:** That the forest commissioner as land agent be and hereby is authorized to convey the interest of the state in lot number twelve, township number two, range six, W. E. L. S., Penobscot county in consideration of the payment by said W. Asahel Darling to the state of Maine the sum equal to the amount of all taxes duly assessed against said lot by the state of Maine together with the interest thereon and such costs as have been paid by said state, the amount to be determined by the said land agent.
