Chapter 32.

Resolve, in Favor of the G. A. R. Cemetery Association of Lewiston.

G. A. R. Cemetery Association of Lewiston, for care of lot. Resolved: That there be, and hereby is, appropriated, to be paid to the G. A. R. Cemetery Association of Lewiston, to aid in repairing into proper condition its cemetery lot in the city of Lewiston, the sum of six hundred dollars.

Approved March 15, 1929.

Chapter 33.

Resolve, Providing for an Increase in State Pension for Perley A. Haskell of Augusta.

Perley A. Haskell, state pension. Resolved: That a pension of eighteen dollars per month be, and hereby is, granted to Perley A. Haskell, of Augusta, to be paid quarterly from the fund for soldiers and sailors and their dependents. Said pension shall begin July first, nineteen hundred and twenty-nine, and continue until otherwise provided by the legislature, and shall be in lieu of the state pension which he is now receiving.

Approved March 15, 1929.

Chapter 34.

Resolve, in Favor of William S. Smith of Alna for State Pension.

William S. Smith, state pension. Resolved: That a pension of fifteen dollars per month be, and hereby is, granted to William S. Smith of Alna, to be paid quarterly from the regular appropriation made for state pensions. Said pension shall begin on July first, nineteen hundred and twenty-nine and continue until otherwise provided by the legislature.

Approved March 15, 1929.

Chapter 35.

Resolve, Providing for a State Pension for Anna Lou Hobart of Farmington.

Anna Lou Hobart, state pension. Resolved: That a pension of fifteen

dollars per month be, and hereby is, granted to Anna Lou Hobart of Farmington, to be paid quarterly from the fund for pensions for soldiers and their dependents. Said pension shall begin July first, nineteen hundred and twenty-nine, and continue until otherwise provided by the legislature.

Approved March 15, 1929.

Chapter 36.

Resolve, Providing for a State Pension for Jennie S. Sutton of Lewiston.

Jennie S. Sutton, state pension. Resolved: That a pension of fifteen dollars per month be, and hereby is, granted to Jennie S. Sutton of Lewiston, to be paid quarterly from the fund for pensions for soldiers and their dependents. Said pension shall begin July first, nineteen hundred and twenty-nine, and continue until otherwise provided by the legislature.

Approved March 15, 1929.

Chapter 37.

Resolve, Providing for a State Pension for Electus Oakes of Thorndike.

Electus Oakes, state pension. Resolved: That a pension of twelve dollars per month be and hereby is, granted to Electus Oakes, of Thorndike, to be paid quarterly from the fund for pensions for soldiers and their dependents. Said pension shall begin July first, nineteen hundred and twenty-nine, and continue until otherwise provided by the legislature.

Approved March 15, 1929.

Chapter 38.

Resolve, Providing for a State Pension for Rosie E. Cook, of Etna.

Rosie E. Cook, state pension. Resolved: That a pension of fifteen dollars per month be, and hereby is, granted to Rosie E. Cook, of Etna, to be paid quarterly from the fund for pensions for soldiers and their dependents. Said pension shall begin July first, nineteen hundred and twenty-nine, and continue until otherwise provided by the legislature.

Approved March 15, 1929.

Chapter 39.

Resolve, in Favor of Eagle Lake.

Eagle Lake, for repair Devoe brook road. Resolved: That the sum
