Chapter 64.

Resolve, in Favor of the Pownal State School for Maintenance.

Pownal State School, for maintenance, etc. Resolved: That there be, and hereby is, appropriated for the Pownal State School:

<p>For personal services; namely, for salaries and wages for all officers and employees except for those wholly engaged in repairs of buildings and equipment, for the two years, July first, nineteen hundred and twenty-nine, to June thirtieth, nineteen hundred and thirty, the sum of eighty-eight thousand nine hundred dollars; July first, nineteen hundred and thirty, to June thirtieth, nineteen hundred and thirty-one, the sum of eighty-eight thousand nine hundred lars,</p>	\$88,900.00	\$88,900.00
<p>For maintenance; namely, for food, supplies, wearing apparel, all articles of personal clothing and materials for their fabrication and repair, for printing reports of said institution up to date, all materials and supplies incident to the maintenance of the institution and patients thereof, whether present or absent, and all farm feed for the two years, July first, nineteen hundred and twenty-nine to June thirtieth, nineteen hundred and thirty, the sum of one hundred thirteen thousand, nine hundred dollars; July first, nineteen hundred and thirty, to June thirtieth, nineteen hundred and thirty-one, the sum of one hundred thirteen thousand, nine hundred dollars,</p>	\$113,900.00	\$113,900.00
<p>For repairs and equipment; namely, all materials, supplies and labor required for repairs, additions and upkeep of grounds, buildings and attached fixtures; all additions to and repairs and replacements of furniture and equipment,</p>

including farm equipment and live stock (exclusive of farm feed) and all personal services rendered wholly in connection with repair work for the two years, July first, nineteen hundred and twenty-nine, to June thirtieth, nineteen hundred and thirty, the sum of fifty-one thousand six hundred fifty dollars; July first, nineteen hundred and thirty, to June thirtieth, nineteen hundred and thirty-one, the sum of fifty-one thousand six hundred fifty dollars,

Provided that the governor and council may, by order upon recommendation of the trustees of said institution, authorize the use of unexpended balances of any of the above appropriation to meet deficiencies in other appropriations for the same institution.

Chapter 65.

Resolve, to Improve the Road to Fort William Henry.

Bristol, town of, appropriation for road. Resolved: That there be, and hereby is, appropriated to repair and improve the present travelled way extending from the main road at Pemaquid Point to Fort William Henry, in Bristol, Maine, the sum of five hundred dollars, the same to be taken from the appropriation for old military reservations and the care of old forts and to be expended under the direction of the governor and council.

Chapter 66.

Resolve, in Favor of the Commissioners of Pharmacy.

Commissioners of pharmacy, for services. Resolved: That there be, and hereby is, appropriated the sum of one thousand dollars for each of the years ending June thirtieth, nineteen hundred and thirty and nineteen hundred and thirty-one, for per diem and expenses of the commissioners of pharmacy, incurred in the performance of their duties.
