CHAP. 74

Chapter 73.

Resolve, in Favor of the Maine State Prison for Maintenance and Current Expenses.

Maine State Prison, for maintenance, etc. Resolved: That there be, and hereby is, appropriated for the Maine state prison for the fiscal year from July first, nineteen hundred and twenty-nine, to June thirtieth, nineteen hundred and thirty, the sum of one hundred ten thousand six hundred and fifty dollars and ninety-two cents for the purposes hereinafter specified, namely:

July 1, 1929-June 30, 1930

Personal services of officers and employees, fifty-five thousand six hundred and fifty dollars and ninety-two cents,	\$55,650.92
Maintenance, including food supplies, clothing, repairs and equipment, and general expenses, fifty thousand dollars,	50,000.00
Retiring and pensioning prison officials, two thousand five hundred dollars,	2,500.00
Permanent improvement, two thousand five hundred dollars,	2,500.00

And be it further resolved that there be, and hereby is, appropriated for the Maine state prison for the fiscal year from July first, nineteen hundred and thirty, to June thirtieth, nineteen hundred and thirty-one, the further sum of one hundred ten thousand one hundred and fifty dollars and ninety-two cents for the purpose hereinafter specified, namely:

July 1, 1930-June 30, 1931

Personal services of officers and employees, fifty-five thousand six hundred and fifty dollars and ninety-two cents,	\$55,650.92
Maintenance, including food supplies, clothing, repairs and equipment, and general expenses, fifty thousand dollars,	50,000.00
Retiring and pensioning prison officials, two thousand dollars,	2,000.00
Permanent improvement, two thousand five hundred dollars,	2,500.00

Chapter 74.

Resolve, in Favor of John M. Eastman.

John M. Eastman, payment of claim. Resolved: That there be, and hereby is, appropriated to be paid to John M. Eastman, the sum of three hundred and thirty-five dollars to reimburse him for money paid out for legal services in defending his title to the office of sheriff of Kennebec county from June fifteenth, nineteen hundred and twenty-six to January twenty-first, nineteen hundred and twenty-seven.
