Chapter 79.

Resolve, in Favor of Caratunk Plantation.

Caratunk, plantation of, payment of claim. Resolved: That there be paid to Caratunk Plantation the sum of seven hundred and forty dollars to reimburse said plantation for the purchase of part of the reserved lands in said plantation occupied by Mary Spaulding. The above amount shall be charged to the reserved land fund held by the treasurer of state for said plantation. The state auditor is hereby authorized to certify said payment, and the treasurer of state is hereby authorized to make the necessary adjustments on his records to comply with the terms of this resolve.

Chapter 80.

Resolve, in Favor of the Penobscot Tribe of Indians for the General Care, Maintenance, and Education Thereof.

Penobscot Tribe of Indians, for general care, etc. Resolved: That there be, and hereby is, appropriated from the state treasury to be expended, under the direction of the governor and council, by the agent of the Penobscot tribe of Indians, for the benefit of said tribe, for the year from July first, nineteen hundred and twenty-nine, to June thirtieth, nineteen hundred and thirty, and for the year from July first, nineteen hundred and thirty, to June thirtieth, nineteen hundred and thirty-one as follows:

Amounting to thirty thousand, nine hundred eighty-five dollars and fifty-five cents, for the year from July first, nineteen hundred and twenty-nine to June thirtieth, nineteen hundred and thirty; and twenty-nine thousand, nine hundred eighty-five dollars and fifty-five cents, for the year from the first of July, nineteen hundred and thirty to June thirtieth, nineteen hundred and thirty-one.

And be it further resolved, that any balance of any of the sub-divisions above named and not required for the purpose, may, upon recommendation of the state auditor, be transferred by the governor and council to pay bills against any of the above sub-divisions, where bills may have been contracted in excess of the amount above set forth.

Resolve, to Provide for a State Pension for Mary W. Chamberlain of Portland.

Mary W. Chamberlain, state pension. Resolved: That a pension of twenty dollars per month be, and hereby is, granted to Mary W. Chamberlain, of Portland, to be paid quarterly from the fund for pensions for soldiers and sailors and their dependents. Said pension shall begin July
