## Chapter 96.

Resolve, in Favor of the State Reformatory for Women for the Erection of a House for Mothers and Babies.

State Reformatory for Women, appropriation for house for mothers and babies. Resolved: That there be, and hereby is, appropriated, for the state reformatory for women, at Skowhegan, for the erection and equipment of a building to be used as a house for mothers and babies, the sum of forty-eight thousand dollars, said appropriation of forty-eight thousand dollars to be expended from surplus revenue funds.

## Chapter 97.

Resolve, Appropriating Money for the Study and Control of the Birch Saw-Fly Leaf Miner and Birch Case Bearer.

Emergency preamble. Whereas, white birch is one of the chief sources of wealth of the state, and the protection of same from insects is of the greatest importance; to this end it is a paramount duty of this legislature to have funds provided without delay for such protection. Delay in the providing of such funds would expose the white birch to danger of destruction by the birch saw-fly leaf miner and birch case bearer, preventable by adequate precautions, now therefore, be it

Birch saw-fly leaf miner and birch case bearer, appropriation for control of. Resolved: That there be and hereby is appropriated the sum of eight thousand dollars for each of the fiscal years nineteen hundred and thirty and nineteen hundred and thirty-one for the study and control of the birch saw-fly leaf miner and birch case bearer, to be expended under the direction of the forest commissioner.

Emergency clause. In view of the emergency expressed in the preamble hereof, this resolve shall take effect when approved.

## Chapter 98.

Resolve, in Favor of the Town of Enfield.

Enfield, town of, appropriation for planking bridge. Resolved: That there be, and hereby is, appropriated to be paid to the town of Enfield, for reimbursement for money expended in planking the bridge known as the "Howland Bridge" which connects the towns of Howland and Enfield, the sum of nine hundred dollars, the money to be paid from the bridge maintenance fund.
