Chapter 109.

Resolve, to Pay Certain Deficiencies.

Deficiencies, appropriation for payment of. Resolved: That the sum of ten thousand, nine hundred and seventy dollars and fifty-two cents be, and hereby is appropriated to pay such deficiencies as shown by the lists presented by the state auditor to the legislature, as amended and allowed by the committee on claims.

Approved April 9, 1929.

Chapter 110.

Resolve, to Aid in Rebuilding the Road in Township Number Ten, Hancock County.

Hancock County, Township No. 10, for repair of road. Resolved: That there be appropriated the sum of five thousand dollars to aid in repairing the road in Hancock county, in township Number Ten, known as the "Blacks Woods Road," the money to be expended from the fund for reconstruction and expended under the direction of the state highway commission, said amount to be available for expenditure in the year nineteen hundred and thirty.

Chapter 111.

Resolve, in Favor of Establishing a Feeding Station or Rearing Station for Fish at, or Near, Machias, in the County of Washington.

Feeding station at or near Machias, appropriation for; conditions. Resolved: That the sum of two thousand dollars be, and hereby is, appropriated, out of the general fund for the maintenance and work of the department of inland fisheries and game, for the purpose of aiding in establishing a feeding station for fish at a suitable point at, or near, Machias, Washington county, said money hereby appropriated to be expended under the direction of the commissioner of inland fisheries and game.

Provided, however, that this appropriation shall not be available unless a free deed of the land upon which said proposed station is to be erected is given to the state; provided, further, that this appropriation shall not be available until the balance necessary to install said station, as determined by the commissioner of inland fisheries and game, shall have been contributed by interested citizens and paid to the state treasurer, to be added to the amount appropriated herein; provided, further, that this appropriation shall not be available until such time as the commissioner

of inland fisheries and game, after careful investigation of existing conditions, has found a location at or near Machias which will afford the proper temperature and supply of water and other conditions necessary for the successful operation of a feeding station for trout and salmon; provided, further, that this appropriation, or any part thereof, if not expended during the year nineteen hundred and twenty-nine shall be available during the year nineteen hundred and thirty.

Chapter 112.

Resolve, in Favor of Memorial at Thomaston, Maine, for Major General Henry Knox.

Memorial for Major General Henry Knox, appropriation for. Resolved: That there be, and hereby is appropriated, the sum of two thousand five hundred dollars for the fiscal year nineteen hundred and twenty-nine and two thousand five hundred dollars for the fiscal year nineteen hundred and thirty for the purchase of a site and construction of a building at Thomaston, Maine, for a memorial for Major General Henry Knox, said sum to be expended, along with other funds privately raised for the purpose by the Knox Memorial Association of said Thomaston.

Chapter 113.

Resolve, Appropriating Money to Aid in the Screening of the Outlet of Lake Messalonskee, in the Town of Oakland, in the County of Kennebec.

Screening of outlet of Lake Messalonskee, appropriation for; conditions. Resolved: That the sum of two thousand dollars be and hereby is appropriated, to be taken from the appropriation for the maintenance of the department of inland fisheries and game, to be expended by the commissioner of inland fisheries and game, to aid in screening Messalonskee lake, at the outlet, in the town of Oakland. Provided, however, that said appropriation for the erection of said screen shall not be available until some responsible corporation or incorporated fish and game club, or the town in which said outlet is located, or some other town in the county of Kennebec, in which said waters are situated, shall have in legal town meeting, and having an article in the warrant for said town meeting for that purpose, by vote of record, voted to assume all liability for the keeping of said screen at all times free from sticks, leaves and all debris so that the same will not become clogged and prevent the free running of water through the same. And provided further that said appropriation
