Chapter 121.

Resolve, Providing for Erection of a Statue at Gettysburg in Memory of Major General Oliver Otis Howard.

Statue in memory of Major General Oliver Otis Howard, appropriation for. Resolved: That there be and hereby is appropriated the sum of ten thousand dollars for the fiscal year nineteen hundred and twenty-nine, and five thousand dollars for the fiscal year nineteen hundred and thirty, and the balance of thirty-five thousand dollars, the governor and council are hereby authorized and empowered to expend at such time as in their discretion there is a sufficient surplus of revenues available after making provision for such other expenditures as under any act or resolve having priority over the expenditure herein provided, for the purchase and erection of an appropriate statue to be erected in the Gettysburg national park at Gettysburg, Pennsylvania, as a monument to the memory of Major General Oliver Otis Howard, a general in the United States army from the state of Maine, who rendered distinguished service on that field, and to the memory of the citizens of Maine who served their country in the Civil War. The governor and council are authorized to receive any donations from any other sources to be expended for the same purpose.

Appointment of committee. Resolved further: That the governor is hereby authorized and directed, upon the approval of this resolve, to appoint a commission of three persons to serve without pay, who are hereby authorized and directed to make all necessary contracts and arrangements for the building and erection of the statue. All the necessary expenses of the commission appointed under the provisions of this resolve incident to the carrying out of the provisions of this resolve shall be paid from the sum hereby appropriated, or donated.

Chapter 122.

Resolve, in Favor of Establishing a Feeding Station or Rearing Pools for Fish at, or Near, Houlton, in the County of Aroostook.

Feeding station at or near Houlton, appropriation for; conditions. Resolved: That the sum of two thousand dollars be, and hereby is, appropriated, out of the general fund for the maintenance and work of the

department of inland fisheries and game, for the purpose of aiding in establishing a feeding station for fish at a suitable point at, or near, Houlton, Aroostook county, said money hereby appropriated to be expended under the direction of the commissioner of inland fisheries and game.

Provided, however, that this appropriation shall not be available unless a free deed of the land upon which said proposed station is to be erected is given to the state; provided, further, that this appropriation shall not be available until the balance necessary to install said station, as determined by the commissioner of inland fisheries and game, shall have been contributed by interested citizens and paid to the state treasurer, to be added to the amount appropriated herein; provided, further, that this appropriation shall not be available until such time as the commissioner of inland fisheries and game, after careful investigation of existing conditions, has found a location at or near Houlton which will afford the proper temperature and supply of water and other conditions necessary for the successful operation of a feeding station for trout and salmon; provided, further, that this appropriation, or any part thereof, if not expended during the year nineteen hundred and twenty-nine shall be available during the year nineteen hundred and thirty.

Chapter 123.

Resolve, Providing for a State Pension for Eva J. Rundlette of Augusta.

Eva J. Rundlette, state pension. Resolved: That a pension of fifteen dollars per month be, and hereby is, granted to Eva J. Rundlette, of Augusta, to be paid quarterly from the fund for pensions for soldiers and their dependents. Said pension shall begin July first, nineteen hundred and twenty-nine, and continue until otherwise provided by the legislature.

Chapter 124.

Resolve, Appropriating Money to Aid in the Screening of the Outlet of Lake Webb, in Franklin County.

Screening of outlet of Lake Webb, appropriation for; conditions. Resolved: That the sum of twelve hundred and fifty dollars be and hereby is appropriated, to be taken from the appropriation for the maintenance of the department of inland fisheries and game, to be expended by the commissioner of inland fisheries and game, to aid in screening Webb lake, at the outlet, in Franklin county. Provided, however, that said appro-
