Chapter 167.

AN ACT Relating to the Licensing of Recreational Camps, Tourist Homes and Similar Places.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 36, secs. 28 and 29; relating to licensing of recreational camps and tourist homes, amended. Sections twenty-eight and twenty-nine of chapter thirty-six of the revised statutes are hereby amended by striking out both of said sections and inserting in place thereof the following:

'Sec. 28. Overnight and recreational camps, roadside, eating and lodging places to be licensed; penalty. No person, corporation, firm or co-partnership shall conduct, control, manage or operate, directly or indirectly, any overnight camp, recreational camp, eating or lodging place which is operated only part of each year, unless the same shall be licensed by the state department of health. Any person, corporation, association, firm or co-partnership violating the provisions of this section shall be punished by a fine of not more than one hundred dollars.

Sec. 29. State department of health authorized to license. The state department of health is empowered to license overnight camps, recreational camps, eating and lodging places which are operated only part of each year.'

Chapter 168.

AN ACT Relating to Payments to County Law Libraries.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 16, sec. 9; relating to payments to county law libraries, amended. Section nine of chapter sixteen of the revised statutes is hereby amended by inserting after the word "Aroostook" in the second line of said section the word 'Cumberland', and inserting after the word "county" in the tenth line the words '(Cumberland); the sum of one thousand dollars', so that said section, as amended, shall read as follows:

'Sec. 9. Cumberland one thousand dollars. The treasurer of each county, except the counties of Aroostook, Cumberland, Kennebec, Lincoln and York, shall pay annually to the treasurer of the law library association of his county for the uses and benefits of the county law library the sum of five hundred dollars. The treasurers of each of the following counties shall pay annually to the treasurer of the law library association of his
