members by the election of citizens from the several towns named in section two hereof, and no member shall be elected from any other towns.

Sec. 8. May receive exhibits. The society may receive exhibits from any town or plantation within the state on such terms and conditions as the society may determine.

Sec. 9. Special meetings; notice. Special meetings of the society for the purpose of amending its by-laws or for any other lawful purposes may be held on the call of the president. The secretary shall cause to be published a notice thereof specifying the purposes for which such meeting is to be held in a newspaper published in Knox county at least thirty days before the date of said meeting.'

Chapter 4.

AN ACT to Extend the Charter of the Patten Water and Power Company.

Be it enacted by the People of the State of Maine, as follows:

P. & S. L., 1923, c. 47; charter extended. The rights, powers and privileges granted by chapter forty-seven of the private and special laws of nineteen hundred and twenty-three entitled "An Act to Incorporate the Patten Water and Power Company" are hereby extended for a term of two years from the time when the same would otherwise expire.

Chapter 5.

AN ACT to Amend the Charter of the Casco Title Guaranty Company.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. P. & S. L., 1927, c. 98, sec. 9; P. & S. L., 1929, c. 3; relating to Casco Title Guaranty Co.; further amended. Section nine of chapter ninety-eight of the private and special laws of nineteen hundred twenty-seven entitled "An Act to Incorporate the Casco Title Guaranty Company" as amended by chapter three of the private and special laws of nineteen hundred twenty-nine is hereby further amended by striking out all of said section nine and inserting in lieu thereof the following:

CHAP. 6

'Sec. 9. Guaranty fund. Said corporation shall set apart a guaranty fund not less in amount than one-fourth of the par value of the capital stock of the corporation issued and outstanding; and as policies of title guaranty are written there shall be added thereto sums equal to five per cent. of that portion of the premiums paid therefor not expended for search of title.

At the end of each fiscal year there may, by vote of the shareholders, be released therefrom a sum equal to five per cent. of that portion of all premiums not expended for search of title which have been paid for policies the liability of the company upon which shall have terminated during the year.

Provided that no additions thereto such as would create a guaranty fund in excess of one-half of the par value of the capital stock of the corporation issued and outstanding shall be required.

No policy of title insurance shall be written at a time when the guaranty fund shall not be maintained in accordance with the foregoing provisions.'

Sec. 2. Reinsurance. An additional section to be known and numbered as section twelve shall be and provide as follows:

'Sec. 12. May reinsure. This corporation is authorized to make contracts with other corporations which may lawfully do so, whether located within or without the state of Maine, for reinsuring its risks in whole or in part.'

Chapter 6.

Be it enacted by the People of the State of Maine, as follows:

P. & S. L., 1927, c. 40; charter extended. The rights, powers and privileges granted by chapter forty of the private and special laws of nineteen hundred twenty-seven entitled "An Act to Incorporate the Blue Hill Water Company" are hereby extended for a term of two years from the time when the same would otherwise expire.
