Chapter 27.

AN ACT to Increase the Powers of the Portland High School Athletic Field Commission.

Be it enacted by the People of the State of Maine, as follows:

P. & S. L., 1929, c. 77, sec. 3; relating to powers of commission, amended. Section three of chapter seventy-seven of the private and special laws of nineteen hundred twenty-nine is hereby amended by adding to said section the following paragraph:

'The said commission shall have power to borrow money and issue notes or other evidences of indebtedness, and to secure the payment thereof by pledge or assignment of any revenues derived from the leasing or letting of said land, facilities and equipment, or by mortgage or pledge of any of its property and assets; but said commission shall not have power to pledge the credit of the city of Portland';

So that said section as amended shall read as follows:

'Sec. 3. Powers of commission increased. The said commission shall have power to lay out and construct, and to hold, manage, control, lease or let, for the purpose of high school and other athletics and other public events, an athletic field, together with bleachers, grand-stands, lockerhouses and other like equipment; and to receive, hold in trust and expend for the laying out, construction, improvement and enlargement of such athletic field, bleachers, grand-stands, locker-houses and other like equipment, such gifts and contributions as may from time to time be made to it.

The said commission shall have power to borrow money and issue notes or other evidences of indebtedness, and to secure the payment thereof by pledge or assignment of any revenues derived from the leasing or letting of said land, facilities and equipment, or by mortgage or pledge of any of its property and assets; but said commission shall not have power to pledge the credit of the city of Portland.'

Chapter 28.

AN ACT to Repeal the Special Law Relating to Political Caucuses in the City of Bangor.

Be it enacted by the People of the State of Maine, as follows:

P. & S. L., 1901, c. 497; relating to political caucuses in city of Bangor, repealed. Chapter four hundred ninety-seven of the special laws of nine-

teen hundred one entitled "An Act in Relation to Political Caucuses in the City of Bangor," and all acts additional thereto and amendatory thereof, are hereby repealed.

Chapter 29.

AN ACT to Authorize the Merging of Pine Grove Cemetery of Portland, Maine, with Evergreen Cemetery of Portland, Maine.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. Pine Grove Cemetery authorized to transfer rights and obligations to city of Portland. Pine Grove Cemetery Association, a corporation organized and existing by law, and located in Portland, in the county of Cumberland, is hereby authorized to transfer and convey its assets and obligations to the city of Portland, the territory comprised within the limits of said Pine Grove Cemetery to be annexed to and become a part of Evergreen Cemetery, such action to be taken after such notice to the members of Pine Grove Cemetery Association as provided in the by-laws of said association, and by the statutes of Maine, and upon such terms and conditions as its members may vote.

Sec. 2. Portland authorized to take over Pine Grove Cemetery. Said city of Portland is hereby authorized to take over and acquire the assets and obligations of said Pine Grove Cemetery Association on such terms and conditions as the city council of the city of Portland may vote, and annex the territory within limits of said Pine Grove Cemetery to said Evergreen Cemetery.

Chapter 30.

AN ACT to Amend Chapter Forty-four of the Private and Special Laws of Eighteen Hundred Eighty-seven Entitled An Act to Incorporate the Skowhegan Water Company, as Amended by Chapter One Hundred Fifty-four of the Private and Special Laws of Nineteen Hundred Seventeen.

Be it enacted by the People of the State of Maine, as follows:

P. & S. L., 1887, c. 44, as amended by P. & S. L., 1917, c. 154, further amended: Section three of said act is hereby amended by adding after the word "Somerset," in the fifth line of said section, the following words:
