CHAP. 60

Chapter 59.

AN ACT to Authorize the Construction of a Weir in the Tide-waters of Chandler Bay in the Town of Jonesport.

Be it enacted by the People of the State of Maine, as follows:

- Sec. r. Edward B. Sawyer and John V. Sawyer authorized to maintain fish weir in Chandler Bay. Edward B. Sawyer and John V. Sawyer of Jonesport, in the county of Washington, and assigns, are hereby authorized to build and maintain a weir for fishing purposes in the tide-waters of Chandler Bay, in said Jonesport, provided said weir does not interfere with navigation or with the rights of others.
- Sec. 2. Location and specifications. The above mentioned weir shall be located as follows: The pound to be located southwesterly and about one hundred yards from the Moose ledge located off Popplestone Beach on the eight feet spot as indicated on United States Coast and Geodetic Survey chart number three hundred four of waters from Cross to Nash Islands, and at Popplestone Beach. Said pound to have a swing of twenty fathoms with two wings or leaders therefrom, one extending in a general northerly direction to the shore of Popplestone Beach, and the other extending in a westerly direction to the shore of said beach.

Chapter 60.

AN ACT to Incorporate the City of Belfast School District.

Be it enacted by the People of the State of Maine, as follows:

- Sec. 1. School district corporation created; purpose. Subject to the provisions of section seven hereof, the city of Belfast shall constitute a body politic and corporate under the name of the City of Belfast School District for the purpose of erecting, equipping, and maintaining a school within said district upon land already secured for the purpose and located on upper High street in said Belfast, or such other land as it may purchase, as is hereinafter provided, for the benefit of the inhabitants thereof.
- Sec. 2. Trustees to manage affairs. All the affairs of said district, as are herein provided shall be managed by a board of trustees composed of five members who shall be elected as is hereinafter provided.
- Sec. 3. Trustees; how elected; organization of board; election of officers; tenure of office; vacancies; compensation. The trustee so to be elected shall
