hereof without cost, and shall determine in its by-laws how the expenses of the corporation and the expense of supplying water shall be apportioned.

Sec. 4. Members of corporation. All persons who are or shall be owners of or interested in the title to the properties described in the first section hereof shall be members of this corporation and each member shall be entitled to one ballot.

Sec. 5. By-laws. Said corporation may make and establish such by-laws for the government of its concerns as may be necessary, not conflicting with the laws of the state.

Sec. 6. Corporate powers vested in board of directors. All the corporate powers of this corporation shall be exercised by a board of directors whose number and term of office shall be determined by a vote of the incorporators at the first meeting.

Sec. 7. Officers of corporation. The officers of this corporation shall be a president, secretary, treasurer, a board of directors, and a clerk who shall be a resident of the state of Maine.

Sec. 8. Calling of first meeting. Either of the corporators is hereby authorized to call the first meeting of the corporation by giving notice by registered mail or in hand, seven days before said meeting.

Sec. 9. Restrictions and exemptions. This corporation shall be subject to the same restrictions and enjoy the same exemptions as corporations organized under the first fourteen sections of chapter seventy of the revised statutes.

Chapter 89.

AN ACT to Authorize York Harbor Village to appropriate Money to Improve a Certain Part of York River.

Be it enacted by the People of the State of Maine, as follows:

York Harbor Village authorized to raise money for certain purpose. York Harbor Village Corporation is hereby authorized, by vote of its inhabitants, to raise money in any manner provided by its charter, for the purpose of dredging or otherwise improving York river between the mouth of said river and the westerly side of the railroad bridge extending across said river. Such work may be done in tide waters on either or both sides

of the channel of said river, and may, when found expedient, be carried out in conjunction with or under the federal government.

Chapter 90.

AN ACT to Incorporate the Madawaska Village Corporation.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. Madawaska Village Corporation created. The territory in the town of Madawaska embraced within the following limits, viz:

Beginning on the bank of the St. John River at the northwest corner of Treaty lot numbered one hundred forty; thence southwesterly on the dividing line of Treaty lots numbered one hundred thirty-nine and one hundred forty to the southwest corner of said lot one hundred forty; thence on the southwest line of said lot one hundred forty to the northwest corner of lot numbered one; thence southerly on the west line of lots numbered one, two, three, four, five, nineteen, twenty, twenty-one, twenty-two, twenty-three, twenty-four, and twenty-nine, as surveyed by Albert A. Burleigh in eighteen hundred seventy-eight, to the northwest corner of lot numbered seventy-nine in St. Agatha; thence on the present dividing line between the towns of Frenchville and Madawaska to the bank of the St. John River; thence down the river to the place of beginning,

and the inhabitants within the same, hereby is created a body politic and corporate by the name of the Madawaska Village Corporation with all the rights and privileges granted by the laws of this state to similar corporations.

At any time after the effective date of this act any three legal voters residing within the territorial limits of said corporation may file a petition with the public utilities commission asking said commission to alter and change the boundary lines of the territory to be included in said corporation, so as to include therein a lesser area; and said commission after such notice as it shall deem sufficient may hold a hearing at a convenient place in the town of Madawaska on such petition and may issue its order defining and prescribing the boundary lines of the territory to be included within said corporation; and after such order shall have been issued only the legal owners residing within such territorial limits so prescribed shall be entitled to vote on the acceptance of this charter and at subsequent meetings of the corporation, and only the property within such territorial limits as prescribed shall be subject to the provisions of this act.
