## Chapter 12.

**RESOLVE**, to Repeal a Resolve Providing for a State Pension for Frank A. Choate.

Resolves, 1929, c. 17; repealed. Resolved: That chapter seventeen of the resolves of nineteen hundred twenty-nine, providing for a state pension for Frank A. Choate, be, and hereby is, repealed.

Approved March 6, 1931.

## Chapter 13.

**RESOLVE**, Providing for an Increase in State Pension for Annie M. Welch of Kennebunk.

Annie M. Welch; state pension. Resolved: That a pension of fifteen dollars per month be, and hereby is, granted to Annie M. Welch, of Kennebunk, to be paid quarterly from the fund for pensions for soldiers and sailors and their dependents. Said pension shall begin July first, nineteen hundred thirty-one, and continue until otherwise provided by the legislature, and shall be in lieu of the state pension which she is now receiving.

## Chapter 14.

**RESOLVE**, Providing for a State Pension for Meda C. Peabody, of Dixmont.

Meda C. Peabody; state pension. Resolved: That a pension of twenty dollars per month be, and hereby is, granted to Meda C. Peabody, of Dixmont, to be paid quarterly from the funds for pensions for soldiers and their dependents. Said pension shall begin January first, nineteen hundred thirty-one, and continue until otherwise provided by the legislature.

**RESOLVE**, Providing for a State Pension for George A. Choate of Montville.

George A. Choate; state pension. Resolved: That a pension of twelve dollars per month be, and hereby is, granted to George A. Choate, of Mont-

Said pension shall begin July first, nineteen hundred thirty-one, and continue until otherwise provided by the legislature.

Said pension shall begin July first, nineteen hundred thirty-one, and continue until otherwise provided by the legislature.

Said pension shall begin July first, nineteen hundred thirty-one, and continue until otherwise provided by the legislature.
