Chapter 23.

RESOLVE, Providing for the Payment of Certain Amounts Due Exhibitors at the Central Maine Fair Association in Nineteen Hundred Twenty-nine, on Account of State Stipend.

Central Maine Fair Association, state stipend. Resolved: That there be paid to Victor Grange and one hundred forty-eight other exhibitors at the Central Maine Fair Association in nineteen hundred twenty-nine the sum of nine hundred twenty-nine dollars and eighty-eight cents being the amount the state of Maine would have paid said association had said association complied with all provisions of section twenty-five of chapter thirty-nine of the revised statutes. Said sum to be distributed among such exhibitors by the commissioner of agriculture in accordance with the amounts awarded them in premiums upon live-stock, agricultural and domestic products but not paid by said society.

Chapter 24.

RESOLVE, Providing for a State Pension for Harold E. Trueworthy of Athens.

Harold E. Trueworthy; state pension. Resolved: That a pension of twenty dollars per month be, and hereby is, granted to Harold E. Trueworthy, of Athens, to be paid quarterly from the fund for pensions for soldiers and their dependents. Said pension shall begin July first, nineteen hundred thirty-one, and continue until otherwise provided by the legislature.

Approved March 16, 1931.

Chapter 25.

RESOLVE, in Favor of the Town of Danforth.

Town of Danforth, compensated. Resolved: That there be, and hereby is, appropriated, the sum of three hundred forty dollars and ninety-eight

cents, in favor of the town of Danforth, to compensate it for money expended for the care of Anna Cropley, a soldier's widow, and her five children.

Approved March 20, 1931.

Chapter 26.

RESOLVE, in Favor of the Town of Stetson.

Town of Stetson, reimbursed. Resolved: That there be, and hereby is, appropriated, to be paid to the town of Stetson, to reimburse it for the amount expended for the operative expenses of Dr. Sheldon and Dr. Emerson, upon Orren Berry, a world war veteran, the sum of fifty dollars.

Approved March 20, 1931.

Chapter 27.

RESOLVE, in Favor of the Town of Stetson.

Town of Stetson; reimbursed. Resolved: That there be, and hereby is, appropriated, to be paid to the town of Stetson, to reimburse it for the amount expended for medical support for Orren Berry, a world war veteran, the sum of fifty-six dollars and fifty cents.

Approved March 20, 1931.

Chapter 28.

RESOLVE, in Favor of Frank Moulton, of Alfred.

Frank Moulton, compensated. Resolved: That there be, and hereby is, appropriated, the sum of three hundred fifteen dollars, in favor of Frank Moulton, of Alfred, to recompense him in full and final settlement of all claims against the state for all damage done to sheep killed by dogs or otherwise.

Approved March 20, 1931.

Chapter 29.

RESOLVE, in Favor of the Town of St. Albans.

St. Albans, compensated for transportation of school children. Resolved: That there be, and hereby is, appropriated, the sum of two
