Chapter 33.**RESOLVE, in Favor of the Town of Frankfort.**

Frankfort, town of, appropriation for. Resolved: That the sum of one hundred dollars be, and hereby is, appropriated, for the town of Frankfort to reimburse the said town for the money due it for the year July one, nineteen hundred twenty-seven to July one, nineteen hundred twenty-eight, inclusive, on account of sub-section three of section two hundred ten of chapter nineteen of the revised statutes, said sum to be paid from the funds of the Department of Education.

Approved March 23, 1931.

Chapter 34.**RESOLVE, for the Laying of the County Taxes for the Year Nineteen Hundred Thirty-one.**

EMERGENCY PREAMBLE. Whereas, the several counties herein-after named have certain expenses and liabilities which must be met as they become due, and such counties have no source of revenue except the taxes herein mentioned, therefore, the appropriations called for in this resolve are immediately necessary for the preservation of the public peace, health and safety, and in the judgment of this legislature these facts constitute an emergency as contemplated by the constitution, now, therefore, be it

Resolved: That the sum annexed to the counties in the following schedule is hereby granted as a tax on each county respectively, to be appropriated, assessed, collected and applied to the purpose of paying the debts and necessary expenses of the same and for other purposes of law, for the year nineteen hundred thirty-one.
