CHAP. 72

Chapter 70.

RESOLVE, in Favor of the National Conference of Commissioners on Uniform State Laws and of the Commissioners from Maine for the Promotion of Uniformity of Legislation in the United States.

Commission on uniform legislation; appropriation for. Resolved: That the sum of five hundred dollars for the period from July first nineteen hundred thirty-one, to July first, nineteen hundred thirty-two, and the sum of five hundred dollars for the period from July first, nineteen hundred thirty-two, to July first, nineteen hundred thirty-three, be and hereby is, appropriated, of which two hundred dollars for the year beginning July first, nineteen hundred thirty-one and two hundred dollars for the year beginning July first, nineteen hundred thirty-two, shall be paid to the National Conference of Commissioners on Uniform State Laws, and so much of the balance for each year beginning July first, nineteen hundred thirty-one, and July first, nineteen hundred thirty-two, as may be necessary shall be paid to the commissioners from Maine for the promotion of uniformity of legislation in the United States, for their expenses in attending the National Conference of Commissioners on Uniform State Laws, for drafting and printing reports, postage, and for their other expenses in performing the duties of said office.

Chapter 71.

RESOLVE, in Favor of the Town of New Sharon.

Town of New Sharon, reimbursed for maintenance of a bridge. Resolved: That there be and hereby is appropriated the sum of twelve hundred seventy-five dollars and no cents to reimburse the town of New Sharon for the maintenance and repairs of the New Sharon bridge; said funds to come from highway maintenance funds.
