## Chapter 79.

### RESOLVE, in Favor of John T. Pratt, of Leeds.

**John T. Pratt; compensation to. Resolved:** That there be, and hereby is, appropriated, the sum of twenty-four dollars and ninety cents, in favor of John T. Pratt, to compensate him for damage to his car and self and wife caused by a moose, from the funds of the Fish and Game Department.
