Chapter 97.**RESOLVE, In Favor of the Town of Plymouth.**

Plymouth; appropriation for repair of bridge in. Resolved: That there be, and hereby is, appropriated, from the highway maintenance fund, the sum of twenty-nine hundred dollars, to aid the town of Plymouth in the repair of the railing on the "Floating Bridge," so-called, in the town of Plymouth. To be expended under the direction of the highway commission.

Approved April 2, 1931.

Chapter 98.**RESOLVE, Providing Pensions for Certain Soldiers and Dependents of Soldiers.**

Pensions granted to certain soldiers and dependents. Resolved: That a pension is hereby granted to each of the persons hereinafter listed in the amount set against their name, to be paid quarterly from the funds for pensions for soldiers and their dependents. Said pensions shall begin on July first, nineteen hundred thirty-one, and shall continue until otherwise provided by the legislature.

Provided, however, that in all cases where the applicants are now receiving a state pension, the amount named herein shall be in lieu thereof and not in addition thereto.
