which facts shall be certified to by the clerk, treasurer, or any of the municipal officers of the town wherein the applicant resides, or wherein the ceremony is to be performed. Upon receipt of such application the secretary of state shall issue to the applicant a license under the seal of the state to the effect that he is authorized to solemnize marriages in this state. Such license, or a certified copy thereof shall be received as evidence in all courts of his authority in the premises, and a copy of the record of any marriage solemnized by such licensee duly made and kept, attested or sworn to by the clerk of the town in which the marriage intention was recorded or in which the marriage was solemnized shall be received in all courts as evidence of the fact of marriage. Such license shall continue until revoked by the governor for cause, after notice and an opportunity to be heard thereon. any person wilfully neglects or refuses to perform any duty imposed upon him by the provisions of this section, he shall be punished by a fine of not more than \$100 for each offense, for the use of the town in which the offense occurred, and the state registrar shall enforce this section as far as it comes within his power and shall notify the county attorney of the county in which said penalty should be enforced of the facts that have come to his knowledge, and upon receipt of such notice the county attorney shall prosecute the defaulting person or persons.'

Sec. 5. Penalty. The first 4 paragraphs of section 14 of chapter 72 of the revised statutes are hereby repealed.

Chapter 25.

AN ACT to Transfer Law Relating to the Courts to the Court Chapter.

Be it enacted by the People of the State of Maine, as follows:

Section 88 of c. 22, transferred. Section 88 of chapter 22 of the revised statutes is hereby repealed and is hereby re-enacted as section 77-A of chapter 91.

Chapter 26.

AN ACT Repealing Obsolete Law.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 12, § 61, repealed. Section 61 of chapter 12 of the revised statutes is hereby repealed.
