## Chapter 51.

### AN ACT Relating to Election Returns in Plantations.

*Be it enacted by the People of the State of Maine, as follows:*

Sec. 1. R. S., c. 8, § 79, amended, relating to list of votes and voters to be returned to the secretary of state from plantations. Section 79 of chapter 8 of the revised statutes is hereby amended to read as follows:

'Sec. 79. Votes, how received; returns to secretary of state. Such assessors shall preside impartially at all such meetings, receive the votes of all voters present, sort, count and declare them in open plantation meeting and in presence of the clerk, who shall form a list of the persons voted for, with the number of votes for each person written out in words against his name, and make a full record thereof in presence of the assessors and in open plantation meeting. ~~The clerk shall make fair copies of the list of voters so posted as corrected, and of the names of all voters on said list who were present and voted at said election, which shall be attested by the assessors and the clerk in open plantation meeting, and he shall cause the record of said votes to be delivered, within the time required by the constitution and the laws, to the person appointed to receive them, and shall cause the copy of the list of voters and of the names of the persons present and voting to be transmitted to the secretary of state with the record of votes aforesaid. The clerk shall transmit the record of votes aforesaid to the secretary of state in the manner provided for the return of record of votes in towns.~~

Sec. 2. R. S., c. 8, § 81, repealed. Section 81 of chapter 8 of the revised statutes is hereby repealed.

## Chapter 52.

### AN ACT Relating to the Taking of Smelts.

*Be it enacted by the People of the State of Maine, as follows:*

Regulating smelt fishing. It shall be lawful to catch smelts with the hands for table use only in the family of the person catching the smelts, said smelts not to be caught and sold, in any of the brooks of the state of Maine, during the months of April and May of each year.

Approved March 10, 1933.
