## Chapter 123.

### AN ACT Relating to Stamping of Registered Boilers.

*Be it enacted by the People of the State of Maine, as follows :*

R. S., c. 54, § 52, amended. Section 52 of chapter 54 of the revised statutes is hereby amended by adding an extra paragraph at the end of the 1st paragraph in said section as follows :

'Registered boilers to be stamped. After a steam boiler has been registered in the department of labor and industry, said department shall furnish, and the owner or user shall stamp, or have stamped, a number as given, on the shell of the boiler in the space commonly used for such purposes, with letters and figures not less than 3-8ths of an inch high. Any person, firm or corporation who fails to so stamp or obliterates or covers such numbers shall be punished by a fine of not more than \$100.'

## Chapter 124.

### AN ACT Relating to Bids for Supplies to Institutions.

*Be it enacted by the People of the State of Maine, as follows :*

Institution supplies to be bid for separately. The state purchasing agent, in requesting bids for institutional supplies, shall list the articles on which bids are requested under the names of the institutions for which they are desired. Bids shall be made on any or all of the articles listed, each bid being made for the supply of a specific article or articles to the particular institution without reference to those otherwise listed.

## Chapter 125.

### AN ACT Relating to Fire Wardens.

*Be it enacted by the People of the State of Maine, as follows :*

R. S., c. 11, § 77, amended. Section 77 of chapter 11 of the revised statutes is hereby amended to read as follows :

'Sec. 77. Duties of fire wardens and deputy wardens; employment of assistants. The chief forest fire wardens, under the direction of the commissioner, shall have general supervision of their respective districts and of the deputy forest fire wardens therein. Each chief forest fire warden,

when directed by the commissioner, shall patrol the forests of his district for the purpose of searching out, extinguishing and guarding against forest fires. He shall investigate and gather evidence regarding the causes of forest fires, enforce all laws relating to forests and forest preservation, arrest all violators thereof, prosecute all offenses against the same, and in this connection shall have the same power to serve criminal processes against such offenders and shall be allowed the same fee as a sheriff, or his deputy, for like services, and shall have and enjoy the same right as a sheriff to require aid in executing the duties of his office. The chief forest fire wardens shall perform such other duties, at such times, and under such rules and regulations as the said commissioner may prescribe, and each shall receive as compensation \$4 for each and every day of actual service, with an allowance for actual necessary expenses of travel ~~and subsistence~~. Deputy forest fire wardens shall perform such duties, at such times and under such rules and regulations, as the commissioner, or the chief fire warden of the district, with the approval of the commissioner, may prescribe. They shall receive as compensation \$3 for each and every day of actual service, with an allowance for actual necessary expenses of travel ~~and subsistence~~, ~~except that when in charge of fire fighting operations they shall be paid at the rate of thirty five cents for each hour of actual service and be provided with subsistence during such service.~~

## Chapter 126.

### AN ACT Relative to the Standish Game Preserve in the Town of Standish, Cumberland County.

*Be it enacted by the People of the State of Maine, as follows:*

R. S., c. 38, § 90, amended. Section 90 of chapter 38 of the revised statutes as amended, so far as it relates to the Standish Game Preserve, is hereby amended to read as follows:

'Standish: the following described territory situated in the town of Standish in the county of Cumberland: Beginning at Standish village, thence extending northeasterly towards Sebago lake to Moody road, so-called, thence along Moody road to the Trail road, so-called, leading from Sebago lake to East Sebago village, thence along said Trail road to Maine Central railroad crossing at Richville, thence northwesterly by said railroad to Steep Falls, thence by the Middle road over Oak Hill, so-called, past the White Place, so-called, and the residence of John Rand to Standish village, ~~except the residences therein and so much of the territory as is used for agricultural purposes.~~
