CHAP. 280

Sec. 3. Cosmetics defined. "Cosmetic preparations" shall mean tonics, lotions, creams, powders, antiseptics, clays, bleaches, colors, dyes, or other substance used with or without mechanical or electrical apparatus to massage, cleanse, stimulate, manipulate, color, bleach or otherwise to treat, improve or to beautify, the scalp, face, neck, shoulders, arms, hands, or to arrange, dress, curl, wave, cleanse, bleach, color or similarly treat the hair of any person.

Sec. 4. Penalty. Whoever violates any provision of the 3 preceding sections, or any ordinance, or by-law, or regulation made thereunder, shall be punished by a fine of not less than \$10 nor more than \$50 for each offense.

Chapter 279.

AN ACT Relating to Kindling of Fires by Non-Residents.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 38, § 51, amended. Section 51 of chapter 38 of the revised statutes is hereby amended to read as follows:

'Sec. 51. Kindling of fires by non-residents, regulated. Non-residents shall not kindle fires upon any unorganized township, while engaged in camping, fishing or hunting from May 1st to November December 1st, without being in charge of a registered guide, except, at public camp sites maintained by the forestry department. No guide shall at the same time guide or be employed by more than 5 non-residents in hunting.'

Chapter 280.

AN ACT to Enable Domestic Mutual Fire Insurance Companies to Obtain
Aid From the Federal Intermediate Credit Bank.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. R. S., c. 60, § 36, amended. Section 36 of chapter 60 of the revised statutes, as amended, is hereby further amended by adding thereto the following:

'Domestic mutual fire insurance companies may become members of and acquire by purchase or otherwise non-assessable stock in agricultural credit corporations or cooperative associations the purposes of which are to obtain

loans for their members from the Federal Intermediate Credit Bank of Springfield or from any mutual or cooperative agency and may borrow from said bank or other such agency for the purpose of paying losses and expenses of operation of the company in advance of assessments. No notes or instruments of indebtedness given in connection with such a loan shall have a maturity date later than I year from the date the loan is made, and shall be repaid from the assessments or other income of the company.'

Sec. 2. Limitations of act. Nothing in this act is intended to restrict or impair in any way the present capacity of any domestic mutual fire insurance company to borrow necessary funds from any source from which it now has legal right to borrow.

Chapter 281.

AN ACT Creating the Baxter State Park Commission, and Defining Its Powers and Duties.

Be it enacted by the People of the State of Maine, as follows:

- Sec. 1. Baxter State Park Commission established. There is hereby created a "Baxter State Park Commission" of 5 members. This commission shall consist of the governor, the forest commissioner, and the commissioner of inland fisheries and game, who shall each serve during his term of office, and 2 other members to be appointed by the governor with the advice and consent of the council, I to serve for 2 years and I to serve for 3 years, and thereafter vacancies in the civilian membership shall be filled by appointments for 3 year terms. The governor shall either act as chairman or shall designate I other member to act as such. The members of the commission shall serve without compensation and I of said commissioners shall be a resident of either the town of Greenville in the county of Piscataquis, or the town of Millinocket in the county of Penobscot.
- Sec. 2. Powers and duties of the commission. The Baxter State Park Commission shall have the following powers and duties:
- I. They shall have the supervision, direction and control of all that portion of Township 3, Range 9, W. E. L. S. in Piscataquis county, containing approximately 5,960 acres of land, donated and conveyed to the state of Maine in trust for state forest, public park and recreational purposes by Percival Proctor Baxter (Governor 1921-1925), by the following deeds: Percival Proctor Baxter to the state of Maine, March 3, 1931, accepted by said state by chapter 23 of the private and special laws of
