Chapter 16.

AN ACT to Extend the Rights, Powers and Privileges of the Sabattus Water and Sewer District.

Be it enacted by the People of the State of Maine, as follows:

P. & S. L., 1929, c. 48, relating to Sabattus Water and Sewer District, charter extended. The rights, powers and privileges of the Sabattus Water and Sewer District, which were granted by chapter 48 of the private and special laws of 1929, are hereby revived and extended for and during a period of 2 years from the date when this act shall take effect; and all the rights, powers and privileges that were granted by said act shall take effect; and all the rights, powers and privileges that were granted by said act to said Sabattus Water and Sewer District may and shall be exercised in the same manner and for the same purpose as provided in said act.

Chapter 17.

AN ACT Relating to the Odd Fellows' Home of Maine.

Be it enacted by the People of the State of Maine, as follows:

P. & S. L., 1917, c. 110, § 3, amended. Section 3 of chapter 110 of the private and special laws of 1917 is hereby amended to read as follows:

Sec. 3. Composition; trustees, other officers, committees, etc.; duties and powers. The corporation hereby created and established shall consist of the grand master, deputy grand master, grand warden, grand secretary and grand treasurer of the Grand Lodge of Maine, Independent Order of Odd Fellows, during their respective and several terms of office, ex-officio, and the Grand Patriarch of the Grand Encampment of Maine, Independent Order of Odd Fellows, during his term of office, ex-officio, and the president of the Rebekah Assembly of Maine, Independent Order of Odd Fellows, during her term of office, ex-officio, and 5 other Odd Fellows and 3 other Rebekahs, all in good and regular standing in their respective lodges, resident within the state of Maine, who shall be known as the trustees of the Odd Fellows' Home of Maine, said Odd Fellow trustees to be elected by the said grand lodge and for such terms of office as said grand lodge shall determine; and said Rebekah trustees to be elected by the said Rebekah Assembly for such term as said grand lodge shall determine; all of said trustees shall be removable for cause by the body electing them. The grand secretary and grand treasurer of said grand lodge, shall, during their several terms of office, be the secretary and treasurer, respectively, of

this corporation. All other officers, agents, committees, employees and servants shall be selected by the corporation. The corporation shall have the power and authority to make, adopt and enforce any and all by-laws, rules and regulations for the government and management of said home and the efficient administration of the powers conferred by this act; provided, however, that such by-laws, rules and regulations shall first be approved by the grand lodge at a regular session thereof; and provided further that said by-laws, rules and regulations may be altered, amended, or annulled by said grand lodge at any regular session thereof. The corporation shall submit to said grand lodge at each regular session a full report of its doings and acts, of all receipts and expenditures, and of the true condition of the home and its funds. Copies of said report shall be furnished to the Grand Encampment and Rebekah Assembly at their regular sessions.'

Chapter 18.

AN ACT Relating to the South Portland Municipal Court.

Be it enacted by the People of the State of Maine, as follows:

P. & S. L., 1895, c. 242; P. & S. L., 1925, c. 37; item VIII, further amended. Item VIII of chapter 242 of the private laws of 1895 as amended by chapter 37 of the private laws of 1925 is hereby further amended to read as follows:

'Item VIII. Salary of judge. The judge of said court shall receive a salary of \$800 per year from the 1st day of January, 1925, to be paid him in quarterly payments from the county treasury of Cumberland county which shall be in full for the services as such judge. All blanks, civil and criminal, dockets and record books, required by said court, shall be furnished by the county of Cumberland. Said judge shall have authority to appoint some suitable person to act as clerk of said court whose duty it shall be to prepare and keep the records of said court and perform such other duties as the judge of said court may direct and who shall receive a salary of \$300 each year to be paid in quarterly payments from the county treasury of Cumberland county which shall be in full for services as such clerk.'
