addressed to him at his usual place of business or residence. Such notice shall be proved by affidavit of the person giving it.

At such 1st meeting, including any adjournment thereof, an organization shall be effected by the choice by ballot of a temporary clerk, who shall be sworn to the faithful discharge of his duties; by the adoption of by-laws consistent with this charter and laws of the state, and by the election in the manner provided by law of directors and such other officers as the by-laws require, provided however that at least 3 of the incorporators hereinbefore named shall be members of the 1st board of directors. The temporary clerk shall record the proceedings until and including the qualification of the secretary of the corporation by his being sworn. No organization shall be effected at any such meeting or its adjournment, unless a majority of the incorporators are present in person.

The board of directors thus elected shall elect a president, an executive committee, a secretary and other officers which under the by-laws they are authorized to choose.

The president, secretary and a majority of the directors shall forthwith make, sign and swear to a certificate setting forth the date of the adoption of this charter by said incorporators, the name and purposes of the corporation, the name of the county where it is located and the number and names of the incorporators acting as directors. Such certificate shall be recorded in the registry of deeds in the county where the principal office is to be located and a copy thereof certified by such register shall be filed in the office of the secretary of state, who shall enter the date of filing thereon and on the original certificate to be kept by the corporation, and shall record said copy in a book kept for that purpose, and from the time of filing such certificate in the office of the secretary of state, the incorporators of said corporation, their successors and assigns, shall be a corporation with the powers hereinbefore granted.

Sec. 7. General insurance laws applicable. Except in so far as they may be inconsistent herewith the general laws with reference to insurance companies shall be applicable to this corporation.

Chapter 31.

AN ACT Relating to Use of Automobiles in Islesboro.

Be it enacted by the People of the State of Maine, as follows:

P. & S. L., 1913, c. 105, repealed. Chapter 105 of the private and special laws of 1913 and all acts or parts of acts amendatory thereof are hereby repealed.
