**CHAP. 48**

**river.** William L. Milliken, of Presque Isle in the county of Aroostook, his heirs and assigns, are hereby authorized and empowered to locate, erect and maintain piers, piles and booms in the Aroostook river on the easterly side of said river and opposite the homestead farm of Walter R. Christie in said town of Presque Isle, for the purpose of collecting, sorting and holding logs and lumber.

**Sec. 2. Passage of logs not to be obstructed.** Said piers and booms shall be so constructed that logs, pulp wood and other lumber shall not be impeded or delayed in their passage down said river, and the expense of such delay, if any, shall be paid by said Milliken, his heirs and assigns.

**Sec. 3. Logs of others to be turned out of Milliken's booms.** Said booms and piers shall also be so constructed that if logs, lumber or other floatable material not owned by said Milliken, his heirs and assigns, be found within said booms, they shall upon notice in writing be turned out of said booms at the expense of said Milliken, his heirs and assigns.

**Chapter 47.****AN ACT Relating to Polling Places in Town of Sanford.**

*Be it enacted by the People of the State of Maine, as follows:*

**Town of Sanford authorized to establish 3 polling places.** The municipal officers of the town of Sanford are hereby authorized to divide at once the said town into not more than 3 convenient polling districts, without public notice and hearing, and notwithstanding the provisions of section 12 of chapter 8 of the revised statutes; and the said municipal officers are hereby empowered to provide the necessary polling places and officers.

**Chapter 48.****AN ACT to Establish a Board of Finance of the City of Waterville.**

*Be it enacted by the People of the State of Maine, as follows:*

**Sec. 1. Board of finance authorized; nominations; terms of office; vacancies; officers; removal.** There is hereby established in the city of Waterville a board of finance for a period of 10 years to be composed of 3 members, all citizens of Waterville, who shall be appointed by the chief justice of the supreme judicial court, one for 1 year, one for 2 years, and one for 3 years; and at the expiration of the term of office of each
