Sec. 18. Limitation. This act shall remain in effect until July 1, 1935 and take effect when approved.

#### Chapter 63.

AN ACT to Acquire the American Portion of the Union Bridge, So-Called, at Calais in the County of Washington, Connecting Maine and New Brunswick; and to Provide for its Maintenance.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. Transfer of international bridge authorized. The mayor and aldermen of the city of Calais, a municipal corporation in the county of

Washington, are hereby authorized to convey and transfer to the state of Maine that portion owned by said city of Calais and known as the American part of the Union bridge so-called, an international bridge across the St. Croix river connecting said Calais with the town of Milltown in the province of New Brunswick, including its part of the foundations, super-structure and approaches, in consideration of the state accepting the same.

Sec. 2. State to maintain international bridge. Upon the tender of a deed by said municipal officers, the state highway commission shall accept it and thereafter the repair and maintenance of the so-called American portion of said international bridge as a free public bridge shall be assumed and continued by the state under the general control, management and direction of the state highway commission.

Approved March 28, 1933.

#### Chapter 64.

AN ACT Providing for Pensions for Call-firemen in Augusta.

Be it enacted by the People of the State of Maine, as follows:

Call-firemen in Augusta may be pensioned. Section 4 of chapter 75 of the private and special laws of 1919, as amended, is hereby further amended by adding thereto the following paragraph:

'Call-firemen may be pensioned. Any "call-fireman" so-called, who has served in the fire department for 30 years or more, may be retired on a pension of \$125 per year.'

This act shall not take effect until it has been adopted by the legal voters of the city of Augusta at the next general election therein, or at a special state election.

Approved March 28, 1933.

### Chapter 65.

AN ACT Relating to Continuing Accounts in Departments Supported by Direct Appropriations.

Emergency Preamble. Whereas, at the present time the funds of several departments of the state have become depleted through extraordinary expenditures made necessary by the economic crisis through which we are now passing, and

Whereas, there are unexpended balances in several of the departments which might be available for transfer to the departments where needed if the governor and council had authority to order such transfer, and
