BUILDING PROGRAM TO RELIEVE UNEMPLOYMENT.

Chapter 107.

AN ACT Authorizing the Governor and Council to Institute a Building Program for State Institutions to Relieve Unemployment.

Whereas, the majority of our state institutions for the relief, improvement and healing of the unfortunate and sick are overcrowded and inadequate so that the lives and health of the inmates are endangered; and

Whereas, there are many deserving cases that should be cared for but that cannot be given consideration because of the lack of accommodation; and

Whereas, the heating plants of many of our state institutions must be renewed very soon; and

Whereas, the federal government has passed an act permitting states to obtain federal aid in erecting state buildings; and

Whereas, the employment of labor in building operations would aid immeasurably in national recovery; and

Whereas, the projects set forth in the following act are necessary to the state and can be completed at a lower cost within the next few years than at any other time; now therefore

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. Governor and council authorized to contract for building program. The governor and council are hereby authorized, empowered and directed to contract for or to authorize and direct the proper state officers to contract for, the construction of the later enumerated projects as soon as the necessary funds are available.

Sec. 2. Definition of "necessary funds." As used in the preceding section "necessary funds" shall mean 'funds available derived from a bond issue authorized for that purpose'; 'funds available from moneys or credits received from the federal government for the purposes set forth in this act and the preamble thereof'; 'funds available from any surplus in the state treasury from and above the operating expenses of the state for that fiscal year'; 'funds available from any direct appropriation by the legislature for any specific purpose covered by this act.'

Sec. 3. Governor and council may choose projects. The governor and council are hereby authorized, in case that the available "necessary funds" are not sufficient for the completion of all of the later enumerated projects, to decide what projects will be completed.

Sec. 4. Projects authorized. The projects listed below and the esti-
