## Chapter 108.

### AN ACT to Incorporate the Atlantic Seaboard Association.

*Be it enacted by the People of the State of Maine, as follows:*

**Sec. 1. Atlantic Seaboard Association incorporated; purposes.** Herbert L. Swett, E. Delmont Merrill, Paul Cloke, Raymond Fellows and George E. Fogg and their associates and successors in office, are hereby constituted a body politic by the name of the Atlantic Seaboard Association for the purpose of acquiring and developing a park and camping reserve in Piscataquis county, in the state of Maine, and of the full development of the human or social values of its lakes, forests and mountains through activities enhancing forest recreation, forest preservation, health, travel, education and the inspiration of fine natural surroundings, with provisions:

(a) that all net income of the corporation be devoted to planning, financing, developing, maintaining and extending the project;

(b) that commercial operations be carried on in view to completing the corporation purposes and making the project self-sustaining as far as possible;

(c) that financial reward of operating heads of commercial projects be determined solely by the trustees as a fair reward for services rendered.

**Sec. 2. Members of the corporation.** The members of the corporation hereby created shall continue in office until the election of their respective successors in office from time to time, when such successors shall become members of this corporation in the place and stead of their respective predecessors; provided, however, that such corporation shall be composed of and have such additional members and their successors as may from time to time be duly provided.

**Sec. 3. Powers of corporation.** The said corporation shall have power to make and adopt a constitution and by-laws, rules and regulations for the government of its business, management of its affairs, regulation of the powers and duties of its officers and agents and from time to time to repeal or alter such constitution and by-laws, including the right to increase or decrease the number of members of the said corporation; except that such members shall be not less than 5 nor more than 15.

**Sec. 4. Extended general powers of the corporation.** In addition to the powers and privileges granted by this act this corporation shall have and possess such general powers as may be necessary to carry into effect the aims and purposes herein specified, in addition to the specific powers herein granted.

## CHAP. 109

**Sec. 5. Specific powers of the corporation.** Said corporation is hereby empowered to solicit, take, receive and hold absolutely or in trust for its general uses and purposes and for any particular department of its work by gift, devise, bequest, grant or purchase, real and personal property and to let, lease, sell, transfer, and convey the same, and to secure the same by mortgages upon the real estate and its improvements. Said corporation may enter also into any contract or commercial arrangement with and acquire and take over the rights or property of any corporation, partnership or individual having any right or property deemed essential to the purposes of the corporation, the more effectively to carry out the aims and purposes herein specified, to make the project self-sustaining so far as possible and to provide for the operation or financing thereof.

**Sec. 6. Existence of the corporation.** The existence of this corporation shall be perpetual.

## Chapter 109.

### AN ACT to Incorporate the Town of Norridgewock School District.

**Emergency preamble.** Whereas, the school building which houses the free high school and common schools of the town of Norridgewock was designed to accommodate no more than 250 pupils and there are now 345 pupils in said building which overcrowds the capacity of said building and the overcrowded condition is dangerous to the health and lives of the students of said school, and

Whereas, it is imperative that action be taken at the earliest possible moment to relieve this dangerous congested condition by the construction of an addition to the present school building and alterations in the existing structure, and

Whereas, if immediate action is taken it will be possible to borrow money from the Federal Government under the Public Works Act; and

Whereas, it will be impossible to borrow the said money unless a School District is created; and

Whereas, construction should be commenced immediately; and

Whereas, in the opinion of the Legislature, these facts render the immediate passage of this act necessary for the preservation of the public peace, health and safety, and constitute an emergency within the meaning of section 16 of Article XXXI of the Constitution of Maine, now therefore,

*Be it enacted by the People of the State of Maine, as follows:*

**Sec. 1. Town of Norridgewock School District, incorporated.** Subject to the provisions of section 7, hereof, the inhabitants of the town of Nor-
